- a) This event is to be conducted in accordance with the New Zealand Transport Agency Code of Practice Temporary Traffic Management (COPTTM) and the Temporary Traffic Management for Local Roads Supplement to NZTA COPTTM Rules and Regulations.
  - b) The supplied Traffic Management Plan containing appropriate signage is approved.
  - c) A separate copy of the relevant liability insurance policy is received.
  - d) That the cost of all advertising is met by the event organiser.
  - e) Emergency Services are contacted regarding the holding of this event.
  - f) The event shall be conducted in accordance with the requirements of the Motorcycling New Zealand Competition Rules Manual.
