Otene Road from the intersection of Ruahapia Road to the intersection with Elwood Road. The road closure will be between 8:00am until 5:00pm, Wednesday, 14 March 2012.

Hastings Street between Heretaunga Street and Eastbourne Street. The road closure will be between 12:45pm – 1:30pm, Friday, 23 March 2012.

- C) That, there being no submissions received, the Council approve the temporary road closures subject to the following conditions to be complied with to the satisfaction of the Group Manager: Asset Management:

- a) These events are to be conducted in accordance with the New Zealand Transport Agency Code of Practice Temporary Traffic Management (COPTTM) and the Temporary Traffic Management for Local Roads Supplement to NZTA COPTTM Rules and Regulations.
- b) The supplied Traffic Management Plans containing appropriate signage are approved.
- c) Separate copies of the relevant liability insurance policy are received.
- d) That the cost of all advertising is met by the event organisers.
- e) Emergency Services are contacted regarding the holding of these events.

With the reasons for this decision being that the objective of the decision will contribute to the Council's Strategic Objectives by:

- i) Develop safe transport networks integrated with land use
- ii) Provide resilient and adaptable social and recreational infrastructure and support services
