5. TEMPORARY ROAD CLOSURES - HASTINGS AND HAVELOCK NORTH - ANZAC DAY SERVICES - 25 APRIL 2012

A) That the report of the Transportation Officer titled Temporary Road Closures - Hastings and Havelock North - ANZAC Day Services - 25

April 2012 dated 5/04/2012 be received.

- B) That, there being no submissions received, the Council approve the following temporary road closures to enable Anzac Day commemorative services:

Hastings:

- Eastbourne Street - Karamu Road to Russell Street South
 - Russell Street South – Eastbourne Street East to Lyndon Road East
- Between 5:15am - 6:15am, Wednesday, 25 April 2012

Havelock North:

- Te Mata Road – Columba Way to the central roundabout
 - Napier Road – Porter Drive to the central roundabout
 - The central roundabout
 - Te Aute Road – Porter Drive to the central roundabout
 - Middle Road – from the National Bank corner to the central roundabout
- Between 9:30am – 11:15am, Wednesday, 25 April 2012

- C) That, there being no submissions received, the Council approve the above temporary road closures subject to the following conditions to be complied with to the satisfaction of the Group Manager: Asset Management:

1. This event is conducted in accordance with the New Zealand Transport Agency Code of Practice Temporary Traffic Management (COPTTM) and the Temporary Traffic Management for Local Roads Supplement to NZTA COPTTM Rules and Regulations.
2. The supplied Traffic Management Plans containing appropriate signage are approved.
3. A separate copy of the relevant liability insurance policy is received.
4. That the cost of all advertising is met by the event organiser.
5. Emergency Services are contacted regarding the holding of this event.

With the reasons for this decision being that the objective of the decision will contribute to the Council's Strategic Objectives:

- i) By facilitating the provision of space for local Anzac Day commemorative services; and
- ii) That the use of the above listed street/roads for these short periods of time will not unreasonably impede traffic
