 - 1. This event is conducted in accordance with the New Zealand Transport Agency Code of Practice Temporary Traffic Management (COPTTM).
 - 2. The supplied Traffic Management Plan containing appropriate signage is approved.
 - 3. A separate copy of the relevant liability insurance policy is received.
 - 4. That the cost of all advertising and signage is to be met by the event organiser.
 - 5. Emergency Services are contacted regarding the holding of this event.

With the reasons for this decision being that the objective of the decision will contribute to the performance of regulatory functions by:

- i) Ensuring that the use of the above listed road for the short period of time will not unreasonably impede traffic.
- ii) Allowing the above temporary road closure the organiser can undertake their event in a safe and controlled environment with all risks minimised and managed.
