3. **CONFIRMATION OF MINUTES -** TE WHAKAMANA I NGĀ MINITI

With the agreement of the Committee, Item 5 was taken out of order and addressed while Council Officers involved were still present.

5. SIX MONTH ACTIVITY REPORT

(Document 21/118)

The Waste and Data Services Manager, Martin Jarvis (HDC) spoke to the main points in the agenda report and responded to questions from the committee.

Some of the main points that Mr Jarvis highlighted, included:

- Paragraphs 3.6, 16.1 and 16.2 the commercial tonnages (year to date) were slightly reduced. However, the special waste tonnages were well above budget.
- The blue line on the "Tonnages by Month" graph showed the volume of rubbish from the Napier flood event in November 2020 taken to the landfill, which had unfortunately resulted in odour issues and a complaint had been received.
- Officers were looking at ways in which odours from the skins and pelts could be managed.
- The upcoming Joint hearing, involving HDC and HBRC was noted.
- Paragraph 5.2 submissions had been received by HBRC which was addressing the "resource consent" issues, while those received by HDC were in relation to the "alteration of the designation". It was understood that all these submissions would be jointly addressed by the commissioners at the hearing, scheduled for some time in June/July this year.
- Informal pre-hearing meetings were being held to try and address any issues that were able to be discussed, to see if progress could be made prior to the hearing itself.
- Section 13.0 "Plant Management Contract" six tenders had been received.
- Existing compactor Officers were suggesting that this plant be retained on site to be used when Area "B" came on-line and used as a back-up to the new compactor which should arrive in July/August 2021.

The Committee acknowledged the work of the officers of both HDC and NCC in regard to the issues that had been highlighted and their overall work in relation to the landfill.

At the next meeting, Officers would present a report on the recent Waste Levy Audit including collection of monies at the landfill gate.
