1. OPENING PRAYER - KARAKIA

The opening karakia was given by Charles Ropitini.



2. APOLOGIES & LEAVE OF ABSENCE - NGĀ WHAKAPĀHATANGA ME TE WEHENGA Ā-HUI

That apologies for absence from Councillor Lawson be accepted.

Leave of Absence had previously been granted to Councillor Apatu.

3. **CONFLICTS OF INTEREST** - HE NGĀKAU KŌNATUNATU

There were no declarations of conflicts of interest.

4. **CONFIRMATION OF MINUTES** - TE WHAKAMANA I NGĀ MINITI

There were no Minutes to confirm.

5. AMENDMENT TO CATEGORY 3 BUY-OUT POLICY

(Document 24/32)

Chief Executive, Nigel Bickle gave a brief overview of this report which had been left to lie on the table from the Council meeting on 1 February 2024.

The Chair advised the meeting that members would need to move recommendations A & B to receive and uplift the report (from 1 February 2024) from the table.

Councillor Kerr/Councillor Buddo

- A) That Council receive the report titled Amendment to Category 3 Buy-Out Policy dated 20 February 2024.
- B) That Council uplift Agenda Item 5 from the Council Meeting held on Thursday 1 February 2024 which was 'left to lie on the table and not further discussed at the meeting' per section 25.2 (d) of the Hastings District Council Standing Orders (adopted by Council on 8 December 2022).

CARRIED

The Chair advised the meeting that there was now a substantive motion on the table to consider, which had been moved by Councillor Schollum and seconded by Councillor Watkins. The substantive motion on the table was recommendations A-E from agenda item 5, from the Council Meeting on 1 February 2024.

This was on page 14 of today's agenda. The Mayor confirmed that she wanted to focus on recommendation B) (which relates to recovering a contribution from eligible property owners towards the cost of demolishing a dwelling under the Voluntary Buy-Out Policy when their insurance proceeds exceed the market valuation of residential improvements or when the property is uninsured).

The mover and seconder Councillor Schollum and Councillor Watkins exercised their right to speak to the motion, and both confirmed that they stood by their comments in the previous Council meeting.

The Chair called for a hand vote to take place for Recommendation B) and directed Councillors that she would not accept abstentions and everyone had to vote.



TIED

(A hand vote was taken – 6 votes FOR and 6 votes AGAINST)

Councillor Schollum requested that her vote FOR the motion be recorded.

The meeting adjourned at 10.10am and reconvened at 10.15am

Chief Executive, Nigel Bickle advised the meeting that in the case of a tied vote, the Chair would have the casting vote in accordance with Standing Orders 19.3.

The Chair announced that she would vote **AGAINST**.

LOST

(6 votes for and 7 votes against)

The Chair announced that the meeting would now deal with the New Motion F) on today's agenda to provide direction for the Chief Executive.

Councillor Kerr/Councillor Fowler

F) That Council direct the Chief Executive to administer the Policy in its current state regards contributions for demolition, and not seek a contribution to demolition costs from eligible property owners under the Policy when their insurance proceeds exceed the market valuation of residential improvements or when the property is uninsured.

CARRIED

Councillor Schollum requested that her vote **AGAINST** the motion be recorded.

Councillor Kerr/Councillor Buddo

A motion from the floor from Councillor Kerr and seconded by Councillor Buddo that a motion be drafted to record the reasons as voiced by individual Councillors for resolving Recommendation F).

G) That Council notes its reasons for recommendation F) include:

Hastings Districts recovery from Cyclone Gabrielle is a partnership of Council, our Hastings Communities and the Crown. It is a long journey that will take five years or more. The principles of the Voluntary Buy-out Policy set in 2023 include acting in good faith, treating people with respect, clearly communicating and delivering outcomes in a timely manner. It was accepted at the time of the Policy development that the costs of demolition would fall on Council. Council in its ongoing collaboration with the Crown will seek Crown assistance with the costs of demolition (in the interests of partnership) and accordingly not seek a specific contribution to demolition from affected property owners.

The Objectives and Principles of the Policy were the basis for community consultation in 2023 when an amendment was made to the Long Term Plan to enable Council to fund the Policy Buy-out process. Council by a majority decision deems that it is most appropriate to remain with the substance of the community consultation.

Substantial work by officers, consultants and Council has gone into development of the Policy. It is a complex process to manage fairness to affected property owners and ratepayers. Council by majority vote is satisfied that the current Policy settings are appropriate.

OFFERS WILL INCLUDE GST, IF ANY, UNLESS COUNCIL DETERMINES THAT A SPECIFIC OFFER SHOULD BE MADE PLUS GST, IF ANY, WHILE CONSIDERING THE POLICY OBJECTIVE OF AFFORDABILITY FOR RATEPAYERS.

D) THAT COUNCIL RESOLVES TO AMEND THE CATEGORY 3 BUY-OUT POLICY AND INSERTS REPLACEMENT CLAUSES FOR CLAUSES 5.1(B)(I), 5.1(C)(I), AND 5.1(C)(II)

THE COUNCIL WILL PREPARE AN OFFER LETTER SUMMARISING THE OUTCOME OF THE VALUATION PROCESS AND RELEVANT BUY-OUT OPTIONS UNDER SECTIONS 4.4 AND 4.5 OF THE POLICY.

CLAUSE 5.1(C)(I)

THE COUNCIL'S REPRESENTATIVE WILL PRESENT THE OWNER WITH **THE OFFER LETTER FOR THE OWNER'S CONSIDERATION.**



CLAUSE 5.1(C)(II)

THE OFFER WILL REMAIN OPEN FOR 3 MONTHS AFTER THE OWNER RECEIVES THE OFFER LETTER AND THE OWNER SHALL ADVISE COUNCIL WHETHER THEY WISH TO PROCEED TO RECEIVING A FORMAL SALE AND PURCHASE AGREEMENT FROM COUNCIL WITHIN THAT TIME. AGREEMENTS TO AN EXTENSION OF TIME WILL NOT BE UNREASONABLY WITHHELD WHERE, IN THE COUNCIL'S REASONABLE OPINION, SUBSTANTIVE PROGRESS IS BEING MADE TOWARDS AN AGREEMENT.
