1.0 Purpose and Summary – Te Kaupapa Me Te Whakarāpopototanga

1.1 The purpose of this report is to update Council on key matters of interest since the last update and provide executive context for the strategic items on this Council Meeting Agenda. The remaining items are important operational matters and are well traversed within the Officer Reports.

Chief Executive Update

- 1.2 At the time you're meeting, Hastings District Council will be mid-way through its public engagement with regard to the establishment of Māori wards following the unanimous decision at the Emergency Council Meeting on Thursday 22 April 2021.
- 1.3 The public engagement running from Friday 23 April is to ensure there is full participation and feedback from the wider community as well as more focussed engagement with local iwi, hapū, post-settlement treaty groups and tangata whenua in Hastings District.
- 1.4 This public engagement will ensure Council can consider all views and preferences prior to making their decision regarding the establishment of Maori wards on Tuesday 18th May 2021.
- 1.5 On other significant matters of interest:
 - Capital Works Update significant progress is being made on our capital works programme:
 Councillors recently visited the construction at the water reservoir at Frimley, consent has been issued and work is underway with the Waiaroha water project and the water treatment plant at Waimārama has been completed.
 - Consent has been received for the coastal works at Cape View Corner with construction due to commence next week.

- Housing it was pleasing to see the subdivision at Tarbet Street. Progress continues on bringing other Council land suitable for residential development to the market over the next 12-18 months.
- Council continues to advocate on behalf of our community the concerns regarding a number of speed limit reductions proposed for major roading networks across our district, such as State Highway 5. We are asking Waka Kotahi for its future investment plan for SH5 that would see the safety issues addressed that will not be fixed by the proposed speed reductions.
- The submission period of Council's Long Term Plan closes on 7 May and staff are working hard to have this feedback put together in an easily-digestible form in time for the Council's hearings in June.
- Hastings District Council has been shortlisted as one of three possible venues for the Local Government New Zealand Annual Conference in 2022. A decision on this will be announced at this year's LGNZ Conference.

Foodeast

- 1.6 Foodeast (formerly known as the Hawke's Bay Food Innovation Hub) cements the region's place as a centre of excellence for food in New Zealand.
- 1.7 It's expected to foster innovation, and collaboration and build industry skills and competence bringing about crucial economic benefits and employment opportunities.
- 1.8 Foodeast has attracted regional support as well as \$12million in funding from the government's Provincial Development Unit.
- 1.9 Detailed design work on this major project will be completed in the next two months, with the main construction due to begin later in the year.
- 1.10 Council is today being asked to make a decision relating to the formation of CCTOs to operate Foodeast, which would own the asset and operate it going forward.

Bylaws Hearing

- 1.11 On Thursday 20th May Council will be meeting to consider the community's submissions on the draft Consolidated Bylaw and Dog Policy Five Year Review process.
- 1.12 Legislative provisions within the Local Government Act 2002 require Council to review existing bylaws after five years.
- 1.13 30 submissions have been received on the review, canvassing a range of topics relating to the bylaw review.
- 1.14 Submissions and officers comments will be provided to Council with the agenda for the 20 May meeting.
- 1.15 Following this hearing, Council will be asked to adopt the final bylaws in August.

Conclusion

1.16 2021 continues to be a very busy year for all areas of Council and I would like to take this opportunity to thank all of our staff for their enormous efforts to serve our community.

Decision on public consultation to form Council Controlled Trading

Subject: **Organisations**

1.0 Executive Summary – Te Kaupapa Me Te Whakarāpopototanga

- 1.1 This report provides the Council with the submissions received from public consultation on the proposal to establish two new Council Controlled Trading Organisations (CCTOs) to operate Foodeast, along with officers' analysis of those submissions.
- 1.2 The purpose of this report is to identify and respond to key themes, ideas and suggestions raised by persons who provided feedback to assist the Council's decision-making.

2.0 Recommendations - Ngā Tūtohunga

- A) That the Council receive the report titled "Decision on public consultation to form Council Controlled Trading Organisations" dated 6 May 2021.
- B) That Council receives and considers the written and verbal submission on the proposal to form a Council Controlled Trading Organisation to establish the two CCTOs to operate Foodeast.
- C) Agrees that the decisions to be made are informed by the written and verbal submissions made in accordance with Local Government Act and that these decisions can be made without further conferring directly with the community or persons likely to have an interest in the decision.
- D) Considers the establishment of two new Council Controlled Trading Organisations (CCTOs) to operate Foodeast.

3.0 Background – Te Horopaki

- 3.1 At its meeting on 18 March 2021, Council considered a report on the Hawke's Bay Food Innovation Hub and resolved:
 - A. That Council approve community engagement as required under the Local Government Act 2002 for the formation of a Council Controlled Trading Organisation to own the assets and operate Foodeast.
 - B. Commence a consultation process with the community in partnership with Hawke's Bay Regional Council, as required under the Local Government Act 2002 s 6 (1) (a) (ii).
- 3.2 The Hawke's Bay Regional Investment Company (HBRIC) investment in Foodeast with Hastings District Council (HDC) investment, could enable the creation of a Local Government Council Controlled Trading Organisation (CCTO).
 - a. Under the Local Government Act 2002 Section 56, Public Consultation is required before a CCTO can be established. (s56 (1) before a local authority may establish or become a shareholder in a council-controlled organisation, the local authority must undertake consultation in accordance with s82.)
 - b. The public consultation process was undertaken in collaboration with the HB Regional Council.

3.3 Structure of Investment:

The investment structure proposed includes the setting up a Limited Partnership and a General Partner. Both will be CCTO's. This structure provides limited liability to the partners, and is used widely in New Zealand. It provides a structure that facilitates investment by entities with different tax regimes. The Limited Partners investment will be in the Limited Partnership and the Limited Partners will be shareholders in the general partner and have the ability to appoint Directors

- 3.4 At its meeting on 28 April 2021, the Hawke's Bay Regional Council resolved as follows: That Hawke's Bay Regional Council:
 - 1. Receives and considers the "Establishment of Two New Council Controlled Trading Organisations (CCTOs) to Operate FoodEast" staff report.
 - 2. Receives and considers the verbal and written submissions on the proposal to Establish Two New Council Controlled Trading Organisations (CCTOs) to Operate FoodEast.
 - 3. Agrees that the decisions to be made are informed by the written and verbal submissions made in accordance with Local Government Act and that these decisions can be made without further conferring directly with the community or persons likely to have an interest in the decision.
 - 4. Agrees to establish two new Council Controlled Trading Organisations (CCTOs) to Operate FoodEast.

4.0 Discussion – *Te Matapakitanga*

4.1 Submission Process

- 4.2 The Statement of Proposal was publicly notified on Thursday 25 March 2021. Notification and subsequent promotion included public notice in the newspaper, media release, and social media, email targeted to relevant organisations and the Council's website.
- 4.3 Consultation closed on Monday 12 April 2021.
- 4.4 All submissions were received through online submission form although a downloadable form was also available on the Council website.

4.5 Submissions Received

- 4.6 A total of 2 submissions were received, with 1 submission supporting the proposal and 1 not supporting the proposal.
- 4.7 Key themes expressed by submitters include:
 - Sustainable future for the region's food industry
 - Provide a workforce to maintain the sector and support growth
 - Innovation encouraged to make the region world class leader
 - A proactive establishment to develop and create opportunities for the region.
 - Council should not be investing in promotion and processing, this should be left to private enterprise.
 - Council can support innovation without this level of involvement.

One submitter had indicated he wished to present his submission in person – the submitter has since advised that he no longer wishes to speak to his submission.

4.8 Officer's Analysis of Submissions

- The proposed Foodeast investment aims to generate positive economic outcomes for the region, in addition to commercial returns for the investors.
- The investment therefore aligns strategically to the role the Council plays in the regional development.
- Foodeast is estimated to deliver 500+ jobs in the region and \$100m increase in regional Gross Domestic Product (GDP).
- Foodeast will be an innovation centre designed to promote more cost-effective food and beverage product innovation, and waste stream utilisation while delivering a base for clustering food technology firms, improving cooperation and bringing in scientific and technical expertise in all areas relating to food innovation (including research activity).

5.0 Options – Ngā Kōwhiringa

Option One - Recommended Option - Te Kowhiringa Tuatahi - Te Kowhiringa Tutohunga

5.1 Council agrees to establish two new Council Controlled Trading Organisations:

Advantages

- Support regional investment to develop a food innovation hub.
- Support diversification of food processing in the region
- Enable potentially \$100m of increased regional GDP
- Enable up to 500 + new jobs in the region

Disadvantages

- Potential reputational damage if Foodeast does not achieve its goals
- HDC funding contribution is limited to \$1m

 A requirement of the Provincial Development Unit (PDU) grant of \$12m is a regional investment contribution of \$6m. The Council investment of \$1m is a part of the regional investment.

Option Two – Status Quo - Te Kowhiringa Tuarua – Te Āhuatanga o nāianei

5.2 Council does not agree to establish two new Council Controlled Trading Organisations

Advantages

- Other sources of funding will be required to deliver Foodeast
- Innovation options may be explored.

Disadvantages

- HBRIC may withdraw from funding Foodeast.
- The PDU may cancel the funding grant to Foodeast.
- Food Innovation and the \$100m in Regional GDP, and 500+ jobs will not be delivered.

6.0 Next steps – Te Anga Whakamua

- 6.1 Delivery of Foodeast as a CCTO:
- 6.1.1 The decision to progress as a majority investor will trigger the creation of the CCTOs. The target timeframe for the formation of the CCTOs is during May (subject to final due diligence).
- 6.1.2 The CCTOs need to be formed, like any other limited company or partnership, meeting all requirements of the Companies Office, Companies Act 1993, and Limited Partnership Act 2008, Local Government Act 2002 and other relevant legislative requirements, including the appointment of Directors, which will occur in compliance with Council policies.
- 6.1.3 Once the CCTOs are formed, contact will be made with the Office of the Auditor General, to request the appointment of an auditor who will conduct annual audits of the business in compliance with the Local Government Act.

Summary of Considerations - He Whakarāpopoto Whakaarohanga

Fit with purpose of Local Government - E noho hāngai pū ai ki te Rangatōpū-ā-Rohe

The Council is required to give effect to the purpose of local government as set out in section 10 of the Local Government Act 2002. That purpose is to enable democratic local decision-making and action by (and on behalf of) communities, and to promote the social, economic, environmental, and cultural wellbeing of communities in the present and for the future.

This report contributes to the purpose of local government by primarily promoting economic development to build a resilient job rich economy.

Link to the Council's Community Outcomes – Ngā Hononga ki Ngā Putanga ā-Hapori

This proposal promotes the Council objective of providing employment for the community with an estimated 500+ full time skilled jobs over 15 years and additional regional GDP of over \$100m over 10 years.

Māori Impact Statement - Te Tauākī Kaupapa Māori

An Iwi representative has participated in the Foodeast establishment board and project team.

Sustainability - Te Toitūtanga

Foodeast will be focusing on sustainable business practices, and sustainable packaging and waste stream utilisation.

Financial considerations - Ngā Whakaarohanga Ahumoni

Foodeast will proceed when regional investment is delivered.

Significance and Engagement - Te Hiranga me te Tūhonotanga

Under the Local Government Act 2002 reference Section 56 Consultation is required before a council-controlled organisation can be established, s56(1)Before a local authority may establish or become a shareholder in a council-controlled organisation, the local authority must undertake consultation in accordance with the Special Consultative Procedure as set out in Section 82 of the Act. The Council's investment of \$1m was consulted on as part of the 2020/2021 Annual Plan.

Consultation – internal and/or external - Whakawhiti Whakaaro-ā-roto / ā-waho

The Foodeast project group and establishment board have met with a wide range of organisations, agencies and businesses during the business case development and engagement with an extensive range of potential investors.

External public consultation was undertaken from 25/03/2021 to 12/04/2021.

Risks

There may be a risk that investors are focussed on occupancy of tenants to generate returns on investment while forgoing the spaces that are required to enable innovation and collaboration spaces for businesses. Achieving Foodeast potential objectives is a key outcome to manage perceptions.



1.0 Executive Summary – Te Kaupapa Me Te Whakarāpopototanga

- 1.1 Subject to Council's decision on public consultation to form two Council Controlled Trading Organisations (CCTOs), Hastings District Council (HDC), Hawke's Bay Regional Investment Company (HBRIC) and Progressive Meats will form a general partnership. The General Partnership will create a Limited Partnership that will own the shares in Foodeast Ltd.
 - Foodeast Ltd is established to deliver a Food Innovation Hub in Hawke's Bay.
- 1.2 HDC has for 3 years been leading the Establishment Phase to deliver a Food Innovation Hub with grant funding and regional investment funding.
- 1.3 There are grant funding agreements, Sale and Purchase Agreements, Supplier contracts and Resource Consent that have been delivered with Establishment Phase funding.
- 1.4 HDC will novate (transfer) the agreements to Foodeast to enable completion of the Establishment, construction and operational phases of Foodeast to deliver a food innovation hub.

2.0 Recommendations - Ngā Tūtohunga

- A) That Council receive the report titled Transfer of Business Legal Establishment Documentation to Foodeast dated 6 May 2021.
- B) That the Council delegate to the Chief Executive authority to novate and sign agreements from Council to Foodeast Ltd set out in the schedule attached, and the balance of the Establishment Phase funding.

3.0 Background – Te Horopaki

- 3.1 At its meeting on 18 March 2021, Council considered a report on Foodeast Regional Investors Update and resolved:
 - A. To note that the proposed Hastings District Council investment of \$1m is budgeted and included in the 2020/21 Annual Plan.
 - B. That the Council approve community engagement as required under the Local Government Act 2002 for the formation of a Council Controlled Trading Organisation to own the assets and operate Foodeast and commence a consultation process with the community in partnership with Hawke's Bay Regional Council, as required under the Local Government Act 2002 s 6 (1) (a) (ii)
 - C. That the Council delegate to the Operations and Monitoring Committee authority to approve the new Council Controlled Trading Organisation (CCTO) Statement of Proposal for Consultation at its meeting on 23 March 2021 in order to meet the timeline for consultation which will run concurrently with Hawke's Bay Regional Council.
 - D. The Council delegates to the Chief Executive the authority to exercise the option in the Sale and Purchase Agreement (attached) to purchase 1ha of land on Hānui Road for the Hawke's Bay Food Innovation Hub (Foodeast).

4.0 Discussion – Te Matapakitanga

- 4.1 The investment structure proposed includes the setting up a Limited Partnership and a General Partner. Both will be CCTOs. This structure provides limited liability to the partners, and is used widely in New Zealand.
- 4.2 The agreements to be novated from Council to Foodeast Ltd include:
 - A conditional Sale and Purchase Agreement was entered into in July 2020 for the purchase of a 1 Ha block of land on Hānui Road at the Tomoana Food Hub.
 - The Funding Agreement with the Provincial Development Unit for a \$12m grant to establish and construct a food innovation hub in Hawke's Bay.
 - Supplier agreements to deliver concept designs, detailed designs, project management and construction contracts.
 - Resource Consent for Hānui Road site.

5.0 Options – *Ngā Kōwhiringa*

Option One - Recommended Option - Te Kōwhiringa Tuatahi – Te Kōwhiringa Tūtohunga

5.1 That the Council delegate to the Chief Executive authority to novate agreements from Council to Foodeast Ltd and the balance of the Establishment Phase funding.

Advantages

- Enables the formation of Foodeast Ltd, which will receive regional investor funding.
- Delivers the condition precedent of the funding agreement with PDU (Provincial Development Unit) for \$12m grant.
- Progresses the design and construction of the Food Innovation Hub facility.

• Provides funding to progress further development.

Disadvantages

Officers have not identified any disadvantages.

Option Two – Status Quo - Te Kōwhiringa Tuarua – Te Āhuatanga o nāianei

5.2 Council will continue to lead delivery of Foodeast.

Advantages

- Outcomes will be aligned with Council Long Term Plan.
- Foodeast perceived to be a neutral area for innovation.

Disadvantages

- Regional Investment will not be achieved.
- Future development will be a financial risk for Council.
- Regional collaboration may be limited.

6.0 Next steps – Te Anga Whakamua

- 6.1 Officers recommend the adoption of Option 1, Council delegate to the Chief Executive authority to novate agreements from Council to Foodeast Ltd and the balance of the Establishment Phase funding. This proposal will enable Foodeast Ltd to progress with the next phases of delivering a Food Innovation Hub.
- 6.2 Officers will recommend that an interim director is appointed to the General Partnership on behalf of Council investment into the CCTO to be called Foodeast Ltd.

The Foodeast project group and establishment board have met with a wide range of organisations, agencies and businesses during the business case development and engagement with an extensive range of potential investors.

Public consultation has been undertaken to establish a CCTO.

1.0 Executive Summary – Te Kaupapa Me Te Whakarāpopototanga

- 1.1 The purpose of this report is to obtain a decision from Council on changes to parking controls on Donnelly Street, Eastbourne Street East, Fredrick Street West, Karamū Road South, Russell Street South and Warren Street North.
- 1.2 This proposal arises from a number of requests for changes in existing parking controls in and around Hastings District and concludes by recommending a number of changes in parking controls and time limits.
- 1.3 A summary of the proposed changes is as follows:

1.4 Amendments to Bylaws require a resolution of Council.

2.0 Recommendations – Ngā Tūtohunga

- A) That the Council Meeting receive the report titled Parking Controls dated 6 May 2021.
- B) That Council resolve pursuant to Clause 5.3.1(a)(iii) of Chapter 5 (Parking and Traffic) of the Hastings District Council Consolidated Bylaw 2016, that the existing parking space located 17 metres south from the intersecting point of Cooper Street and extending 6 metres north on the eastern side of Donnelly Street becomes a mobility parking space.
- C) That Council resolve pursuant to Clause 5.3.1(a)(i) of Chapter 5 (Parking and Traffic) of the Hastings District Council Consolidated Bylaw 2016, that the existing two P60 parking spaces located 36 metres from the intersecting point of Hastings Street South and extending 15 metres west on the northern side of Eastbourne Street East be revoked and becomes a P5 Loading Zone.

- E) That Council resolve pursuant to Clause 5.3.1(a)(i) of Chapter 5 (Parking and Traffic) of the Hastings District Council Consolidated Bylaw 2016, that the existing parking spaces located 3 metres south from the intersecting point of Tawa Street and extending 26 metres south on the southern side of Frederick Street West become P5 parking spaces between 8am 9am and 2-45pm 3-30pm week days only.
- F) That Council resolve pursuant to Clause 5.3.1(a)(i) of Chapter 5 (Parking and Traffic) of the Hastings District Council Consolidated Bylaw 2016, that the existing five P60 parking spaces located 21 metres south from the intersecting point of Heretaunga Street East and extending 32 metres south on the eastern side of Karamū Road South become a Clearway Area from 11pm until 6am 7 days a week.
- G) That Council resolve pursuant to Clause 5.3.1(a)(i) of Chapter 5 (Parking and Traffic) of the Hastings District Council Consolidated Bylaw 2016, that the existing P15 Parking located 29 metres south from the intersecting point of Heretaunga Street East and extending 28 south on the western side of Russell Street South be revoked.
- H) That Council resolve pursuant to Clause 5.3.1(a)(i) of Chapter 5 (Parking and Traffic) of the Hastings District Council Consolidated Bylaw 2016, that the parking spaces located 29 metres south from the intersecting point of Heretaunga Street East and extending 28 south on the western side of Russell Street South become P60 parking.
- I) That Council resolve pursuant to Clause 5.3.1(a)(i) of Chapter 5 (Parking and Traffic) of the Hastings District Council Consolidated Bylaw 2016, that the existing 4 P120 parking spaces located 52 metres north from the intersecting point of Heretaunga Street East and extending 22 metres north on the eastern side of Warren Street North be revoked.
- J) That Council resolve pursuant to Clause 5.3.1(a)(iii) of Chapter 5 (Parking and Traffic) of the Hastings District Council Consolidated Bylaw 2016, that the existing parking spaces located 64 metres north from the intersecting point of Heretaunga Street East and extending 11 metres north on the eastern side of Warren Street North becomes a mobility parking space.

3.0 Background – Te Horopaki

- 3.1 From time to time it is necessary to introduce parking controls and/or amend those that are already in place.
- 3.2 In order that the changes are legally established and enforceable, a formal resolution by Council is required.
- 3.3 The following information provides the background and current situation relevant to the changes being proposed.

4.0 Discussion – Te Matapakitanga

4.1 Donnelly Street – Mobility Park (Recommendation B)

Hastings District Council has been approached by a business and members of the public to install a mobility park in Donnelly Street.

After discussions with the traffic operations engineer and parking wardens the parking space outside number 10 Donnelly Street was deemed to be the safest location. This area already has an easily accessible dropdown for mobility users to use, so no modification of the existing footpath area is needed.



4.2 Eastbourne Street East – Time Limit Changes – P5 Loading Zone and P15 Time Limit (Recommendations C and D)

Toitoi approached Hastings District Council to change the parking configuration located around the area of the ticketing office.

The P15 will help traffic turnover quickly when the ticketing office is open, allowing more people to visit.

The P5 Loading Zone will allow for the safe unloading and loading of stage equipment, exhibition items and general deliveries to the area.




4.3 Frederick Street West – P5 Parking (Recommendation E)

Frederick Street Kindergarten approached Hastings District Council about having P5 time limits outside their premises.

The P5 will have a limit of when it can be enforced. The times are 8am to 9am and then 2:45pm to 3:30pm.

With the combination of 2 schools and 1 childcare centre and 1 kindergarten being in the immediate area there is no safe place for parents to drop off and pick up their children.

This area will provide an efficient and safe place for parents and children.



4.4 Karamu Road South – Clearway Area (Recommendation F)

Police have requested that the area by Albert Square opposite Bar213 become a Clearway area between 11pm and 6am 7 days a week.


This would give police the ability to move people who are aiming to incite disorder while sitting in their cars.

Allow for more taxi vehicles to efficiently and safely move people away from the area.

Allow a better view of the square, lessening the incidence of concealed liquor ban breaching or public disorder.

Taxi drivers parked up in the area waiting for the end of the night adds more responsible 'guardians.'


This would create a safer area during the night.



4.5 Russell Street South – Time Limit Changes – Revoke P15 and Change to P60 (Recommendations G and H)

Members of the public have queried why the P15 parking is still there as this causes confusion due to the area being predominantly P60.

Increasing the time period will allow for longer stays at the café and other businesses in the area without having to worry about incurring a parking infringement.




4.6 Warren Street North – Revoke 4 P120 Spaces – Establish a Mobility Park (Recommendations I and J)

Hastings District Council have revamped the Landmarks area in Warren Street North resulting in the loss of 4 P120 parking spaces.

Two of these carparks have been turned into a mobility park.

The mobility park has been established to allow mobility users easier access to the landmarks area and businesses in the area.

1.0 Purpose and summary - Te Kaupapa Me Te Whakarāpopototanga

- 1.1 The purpose of this report is to seek Council approval for proposed amendments to the Schedule of Appointments to Committees, Subcommittees and Other External Organisations 2019-2022, namely:
 - To note that the Education Link Group, which has not met since the 2019 elections, is in hiatus due to Covid-19.
 - To replace Councillor Schollum with Councillor Nixon on the Active Transport Group.
 - To remove Councillor Harvey from the Omarunui Refuse Landfill Joint Committee and for Council appoint a replacement HDC representative on that Committee.
 - To appoint Councillor Schollum, (current Deputy Chair) as Chair of the District Development Subcommittee, and Deputy Mayor Councillor Kerr (current Chair) as Deputy Chair of the District Development Subcommittee.
- 1.2 Deputy Mayor Councillor Kerr as Deputy Chair has advised the Mayor of her wish to vacate position of Chair of the District Development Subcommittee in favour of the current Deputy Chair Councillor Schollum. Subject to Council's approval of the change of Chair, Councillor Kerr will assume the role of Deputy Chair of the Subcommittee. The Mayor supports the proposed change in roles.
- 1.3 The change to the Chair of the District Development Subcommittee will have an impact on the remuneration levels of all Councillors which are calculated based on individual councillors' highest level of responsibility that they hold. Any proposed change to remuneration levels must be forwarded to the Remuneration Authority for approval.
- 1.4 The report concludes by recommending:

2.0 Recommendations – Ngā Tūtohunga

- A) That the Council receive the report titled Proposed Amendments to Appointments to Committees, Subcommittees, Joint Committees and External Organisations dated 6 May 2021.
- B) That the Council approve the following amendments to the Schedule of Appointments to Committees, Subcommittees and other external organisations 2019-2022:
 - 1) That it be noted on the schedule that the Education Link Group which has not met since the 2019 elections is on hiatus due to Covid-19.
 - 2) That Councillor Nixon replace Councillor Schollum on the Active Transport Group.
 - 3) That Councillor Harvey be replaced on the Omarunui Refuse Landfill Joint Committee, and a replacement HDC member be appointed.
 - 4) That Councillor Schollum replace Councillor Kerr as Chair of the District Development Subcommittee, and Councillor Kerr be appointed as Deputy Chair of the Subcommittee.

3.0 Background

- 3.1 At its meeting on 10 December 2019, the Council resolved as follows in relation to Agenda Item 19. Council Delegations and Appointments to Committees, Subcommittees, Joint Committees and External Organisations:
 - A) "That the Council receives the report titled Council Delegations and Appointments to Committees, Subcommittees, Joint Committees and External Organisations.
 - B) The Delegation Scheme (Attachment 1) (PMD-01-06-19-325) be adopted subject to the following amendments:-
 - District Development Subcommittee 8 members (quorum 4) Great Communities Subcommittee – 8 members (quorum 4)
 - C) That the recommendations of Her Worship the Mayor in respect of the appointments to Committees, of Chairs, Deputy Chairs of the Committees, External Appointees and District Champions be adopted and the people listed in the "Draft Schedule of Appointments to Committees, Subcommittees and other External Organisations 2019-2022" as amended (CG-14-1-01634) be appointed accordingly.

- 3.4 The 10 December 2019 Council Meeting then resolved the schedule of Elected Members' Payments (which had been calculated on the basis of the draft Schedule of Appointments to Committees, etc. referred to in part C) of the resolution above) be approved and sent to the Remuneration Authority for Determination.
- 3.5 At that time, there were 4 Subcommittee Chair positions and 5 Deputy Chair positions. The proposed change of role for Councillor Schollum from Deputy Chair to Subcommittee Chair would increase the number of Subcommittee Chairs to 5 and reduce the number of Deputy Chairs to 4, which will require an adjustment to the remuneration level of all councillors.
- 3.6 Councillor Schollum's highest level of responsibility currently is that of Deputy Chair. If the Council approves her appointment to the position of Chair of the District Development Subcommittee, her proposed new rate of remuneration would be \$55,843 p.a. The other Subcommittee Chair positions would be adjusted to the same amount.

- 3.7 As the Elected Members' Remuneration Pool is set by the Remuneration Authority and there would be no financial impacts to the Council. However, any proposed change in remuneration levels for elected member positions of responsibility will require a Council decision which is then referred to the Remuneration Authority. This will be gazetted as a change to primary legislation and could take a few months. Once the changes have been approved by Parliament we can then action the payments through our payroll backdated to the date of the Council Meeting. This means that if the Council approves the changes, all elected members (except the Mayor and newly appointed Subcommittee chair) can expect a small backdated salary reduction to claw back the difference in salaries once the Remuneration Authority notifies the Council that the change has been approved.
- 3.8 If Council agrees with the proposed changes, the effect on remuneration from Changes to Additional Responsibilities would be as follows:
