- 5) Recommend to Council the appointment of Trustees to Te Mata Park Trust Board in accordance with the policy on Appointment of Trustees for Te Mata Park Trust Board, and the provisions of section 57 of the Local Government Act 2002.

1.0 Executive Summary – *Te Kaupapa Me Te Whakarāpopototanga*

- 1.1 The purpose of this report is to obtain a decision from the Civic and Administration Subcommittee in regard to the following temporary road closures as requested below. This request arises from the need to inform and gain Hastings District Council (“the Council”) approval in order to comply with the legal process to temporarily close the roads listed below:
- The Hawke’s Bay Car Club (HBCC): **Salisbury Road** from #1019 to Gwavas Road including Kereru Road intersection from 6:00am until 10:00am Saturday, 23 July 2022. The purpose of this road closure is to hold a motorsport event.
 - The Hastings District Council: **Heretaunga Street** between Warren Street and Hastings Street from 8:00am to 6:00pm Saturday 6th August 2022. The Purpose of this road closure is for a building opening ceremony.
 - The Hastings District Council: **Hastings Street** between Heretaunga Street and Eastbourne Street from 11:30am to 8:00pm Saturday 20th August 2022. The purpose of this road closure is to hold a Celebration of Pasifika.
- 1.2 Given that there are no submissions in opposition to the closures and subject to the recommended conditions the activities can proceed and be undertaken in a safe and controlled environment. The risks associated with these closures can then be minimised and safely managed to Council’s satisfaction.
- 1.3 As part of the notification process for these proposed temporary road closures, representatives visited each of the persons deemed to be affected by the proposed closures. This is an important part of each proposed temporary road closure and is undertaken by the respective applicant

involved. Details of the consultation undertaken in regard to the above proposed temporary road closures are set out under the consultation section of this report.

2.0 Recommendations - Ngā Tūtohunga

- A) That the Civic and Administration Subcommittee receive the report titled Temporary Road Closures - Salisbury Road, 23 July 2022 - Heretaunga Street, 6 August 2022 - Hastings Street, 20 August 2022 dated 18 July 2022.
- B) That the Civic and Administration Subcommittee approve the following temporary road closures subject to no submissions or objections having been received in respect of these applications and on the basis that this events would be subject to any Covid-19 provisions in force as at the following date:
 - i. The Hawke's Bay Car Club (HBCC): **Salisbury Road** from #1019 to Gwavas Road including Kereru Road intersection from 6:00am until 10:00am Saturday, 23 July 2022. The purpose of this road closure is to hold a motorsport event. No objections have been received.
 - ii. The Hastings District Council: **Heretaunga Street** between Warren Street and Hastings Street from 8:00am to 6:00pm Saturday 6th August 2022. The purpose of this road closure is for a building opening ceremony. Canvassing of property owners was not able to completed prior to the distribution of the agenda.
 - iii. The Hastings District Council: **Hastings Street** between Heretaunga Street and Eastbourne Street from 11:00am to 8:00pm Saturday 20th August 2022. The purpose of this road closure is to hold a Celebration of Pasifika event. No objections have been received.

Subject to the following conditions to be complied with to the satisfaction of the Group Manager: Asset Management:

- i. These events are conducted in accordance with the New Zealand Transport Agency Code of Practice Temporary Traffic Management (CoPTTM).
- ii. The Traffic Management Plans including provision for appropriate signage is approved by the Traffic Management Coordinator acting under delegated authority.
- iii. The Traffic Management Plans must be complied with including any specific conditions.
- iv. Copies of the relevant liability insurance policies are received.
- v. That the cost of all advertising is met by the event organisers.
- vi. Emergency Services are contacted regarding the holding of this event with details of the dates, locations and time frames.
- vii. As per the Traffic Management Plan provisions - all emergency services will be accommodated and access provided through the sites as required.
- viii. The applicant/s are responsible under the Health and Safety at Work Act 2015 for all health and safety risks associated with this activity and must take reasonably practicable steps to ensure the safety of all persons during these temporary road closures.
- ix. The applicant/s have in place at all times, appropriate Health and Safety measures (to prevent harm to any persons), including (but not limited to) any measures provided for in the submitted Health and Safety Plans including any conditions attached.

3.0 Background – Te Horopaki

3.1 This report covers the application to hold events, being:

- i) The Hawke's Bay Car Club (HBCC) Motor sport event: **Salisbury Road** from #1019 to Gwavas Road including Kereru Road intersection from 6:00am until 10:00am Saturday, 23 July 2022. The purpose of this road closure is to hold a motorsport event.
- ii) The Hastings District Council Opening Ceremony: **Heretaunga Street** between Warren Street and Hastings Street from 8:00am until 6:00pm Saturday 6th August 2022. The purpose of this road closure is to hold a building opening ceremony.
 - a. The owners of the properties in this block will be advised of the proposed temporary road closure prior to the meeting date. To date no objections have been received, but officers are actively contacting the property owners to ensure they are aware of this event. Officers will confirm the outcome of this part of the process at the meeting.
 - b. Copies of the completed visiting forms will be tabled at the meeting. Due to timing they are not able to be attached as part of the agenda for the meeting.
- iii) The Hastings District Council Celebration of Pacifica event: **Hastings Street** between Heretaunga Street and Eastbourne Street from 11:30am to 8:00pm Saturday 20th August 2022. The purpose of this road closure is to hold a Celebration of Pasifika event.
 - a. The church manager has been advised of this event and has no objection to this taking place. The church is the only affected party in this case.

3.2 The above temporary road closures will be managed in accordance with the New Zealand Transport Agency Code of Practice Temporary Traffic Management (CoPTTM).

3.3 Traffic Management Plans (TMP) are to be submitted to the Hastings District Council and the TMPs will be approved for implementation, subject to the temporary road closure applications being approved.

3.4 A temporary road closure checklist, set out under the consultation section of the report, details the necessary items that the organisers need to submit as part of their applications for the above proposed temporary road closures.

3.5 GIS maps showing the extent of the proposed temporary road closures are attached (**Attachments 1, 2 and 3**).

3.6 At the time of writing this report there were no planned road works that will affect or impact the above temporary road closures.

4.0 Discussion – Te Matapakitanga

4.1 The above events are being undertaken by:

The Hawke's Bay Car Club - this will be the first temporary closure of this section of **Salisbury Road** during the 2022 calendar year. The average daily traffic count for Salisbury Road is 38 vehicles per day.

The Hastings District Council – this will be the first temporary closure of this section of **Heretaunga Street** during the 2022 calendar year. The average daily traffic count for Heretaunga Street is 4677 vehicles per day.

The Hastings District Council – this will be the first temporary closure of this section of **Hastings Street** during the 2022 calendar year. The average daily traffic count for Hastings Street is 6718 vehicles per day.

The above roads have been chosen specifically for their suitability for holding the respective events or services.

5.0 Options – Ngā Kōwhiringa

Option One - Recommended Option - Te Kōwhiringa Tuatahi – Te Kōwhiringa Tūtohunga

- 5.1 Option A is the preferred option. It recommends the Committee approve the temporary road closures detailed above, subject to conditions that will ensure public safety is maintained.

Temporary road closure options listed below:

- **Option A:** Approve some or all of the temporary road closures detailed above.
- Advantages: These events can proceed and contribute to the safe use of roads within the district for these proposed events.
- Disadvantages: Traffic will be impeded for a short period of time on specific roads.
- **Option B:** Do not approve any of the temporary road closures detailed above.
- Advantages: Traffic will not be impeded.
- Disadvantages: The proposed events may need to be cancelled.

6.0 Next steps – Te Anga Whakamua

Summary of Considerations - He Whakarāpopoto Whakaarohanga

Fit with purpose of Local Government - E noho hāngai pū ai ki te Rangatōpū-ā-Rohe

The Council is required to give effect to the purpose of local government as set out in section 10 of the Local Government Act 2002. That purpose is to enable democratic local decision-making and action by (and on behalf of) communities, and to promote the social, economic, environmental, and cultural wellbeing of communities in the present and for the future.

“11. The council may, subject to such conditions as it thinks fit (including the imposition of a reasonable bond), and after consultation with the Police and the Ministry of Transport, close any road or part of a road to all traffic or any specified type of traffic (including pedestrian traffic).”

“(e) For a period or periods not exceeding in the aggregate 31 days in any year for any exhibition, fair, show, market, concert, film-making, race or other sporting event, or public function:

Provided that no road may be closed for any purpose specified in paragraph (e) of this clause if that closure would, in the opinion of the council, be likely to impede traffic unreasonably.”

This report contributes to the purpose of local government by primarily promoting the cultural and social wellbeing of the community.

The above proposed temporary road closure has been posted on the Council website and formal public notification was published in the Hawke’s Bay Today newspaper on Saturday, 4th June 2022.

The closing date for submissions was 4:00pm, Monday 20th June 2022. No submissions were received.

If the road closure is approved, final formal public notification will be published in the Hawke’s Bay Today newspaper on Thursday, 21st July 2022.

2. Hastings Street

The above proposed temporary road closure has been posted on the Council website and the formal notification was published in the Hawkes Bay Today newspaper on Saturday, 25th June 2022.

The closing date for submissions was 3:00pm, Monday 4th July 2022. No submissions were received.

If the Road Closure is approved final formal notification will be published in the Hawkes Bay Today on Saturday, 30th July 2022.

3. Heretaunga Street

The above proposed temporary Road Closure has been posted on the Council website and the formal notification was published in the Hawkes Bay Today newspaper on Monday, 27th June 2022.

The closing date for submissions was 4:00pm Wednesday, 6th July 2022. No submissions were received.

If the Road Closure is approved final formal notification will be published in the Hawkes Bay Today on Saturday, 30th July 2022.

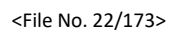

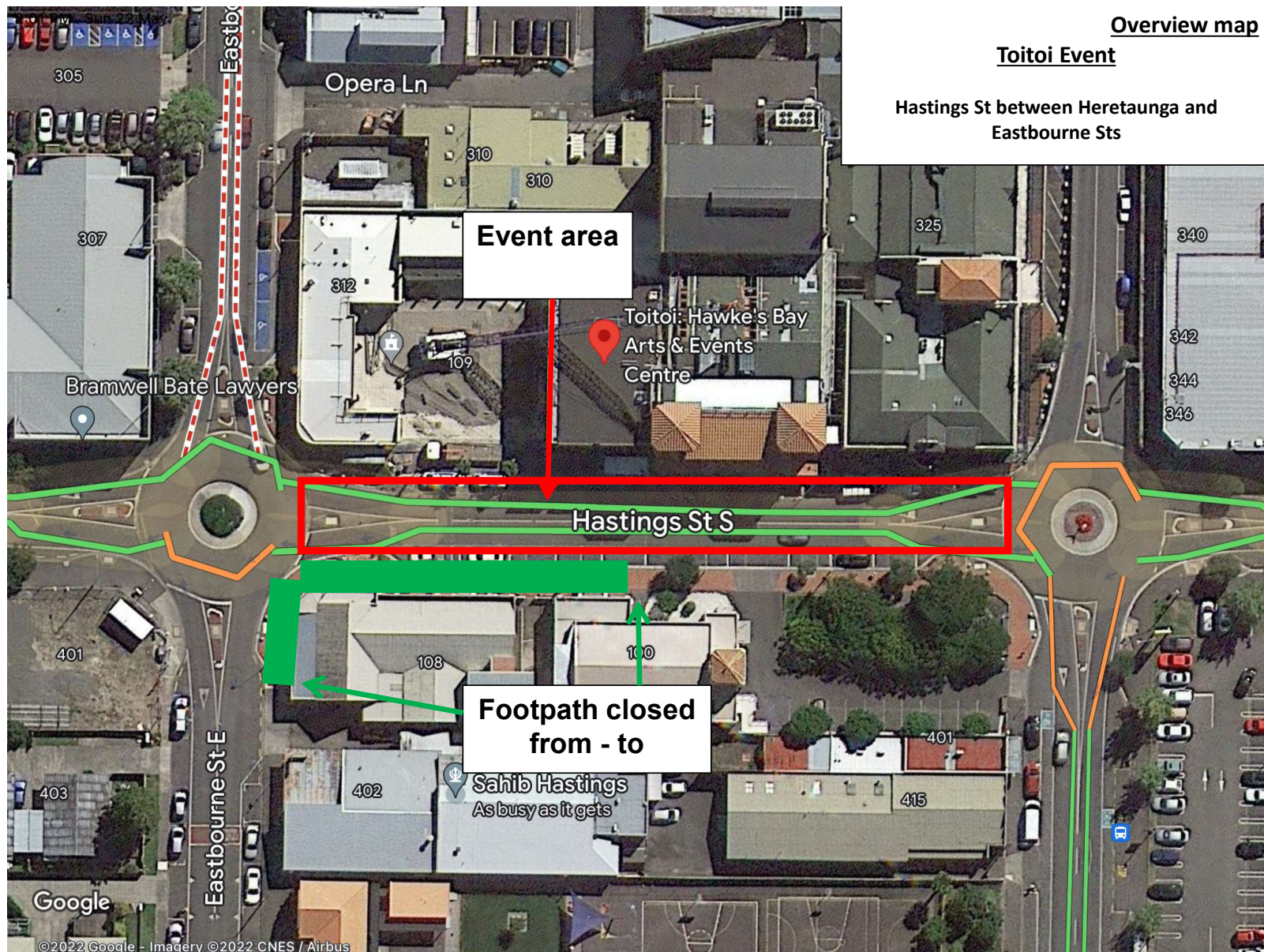
