1.0 Executive Summary – *Te Kaupapa Me Te Whakarāpopototanga*

1.1 The purpose of this report is to obtain a decision from the Civic and Administration Subcommittee in regard to the following temporary road closures as requested below. This request arises from the need to inform and gain Hastings District Council ("the Council") approval in order to comply with the legal process to temporarily close the roads listed below:

Blossom Weekend. Karamu Road from Eastbourne St East to Heretaunga St & **Heretaunga St** from Karamu Rd to Warren St. The road closure will be between 8.00am to 8.00pm, Sunday, 25th September 2022. The purpose of this road closure is the Blossom Weekend Festival.

The Spring Show. **Prospect Road** Between Royston and King Street from 6-00am until 7-00pm Saturday, 15th October 2022. The purpose of this road closure is Spring Carnival Race Day.

- 1.2 Given that there are no submissions in opposition to the closures and subject to the recommended conditions the activities can proceed and be undertaken in a safe and controlled environment. The risks associated with these closures can then be minimised and safely managed to Council's satisfaction.
- 1.3 As part of the notification process for these proposed temporary road closures, representatives visited each of the persons deemed to be affected by the proposed closures. This is an important part of each proposed temporary road closure and is undertaken by the respective applicant involved. Details of the consultation undertaken in regard to the above proposed temporary road closures are set out under the consultation section of this report.

2.0 Recommendations - Ngā Tūtohunga

- A) That the Civic and Administration Subcommittee receive the report titled Temporary Road Closures - Blossom Weekend - 25 September 2022 and Spring Show - 15 October 2022 dated 6 September 2022.

 - Blossom Weekend: Karamu Road from Eastbourne St East to Heretaunga St & Heretaunga St from Karamu Rd to Warren St. The road closure will be between 8.00am to 8.00pm, Sunday, 25th September 2022. The purpose of this road closure is to hold the Blossom Weekend Festival.
 - ii. The Spring Show: Prospect Road Between Royston and King Street from 6.00am until 7.00pm, Saturday 15th October 2022. The purpose of this road closure is to hold Spring Carnival Race Day.

Subject to the following conditions to be complied with to the satisfaction of the Group Manager: Asset Management:

- i. These events are conducted in accordance with the New Zealand Transport Agency Code of Practice Temporary Traffic Management (CoPTTM).
- ii. The Traffic Management Plans including provision for appropriate signage is approved by the Traffic Management Coordinator acting under delegated authority.
- iii. The Traffic Management Plans must be complied with including any specific conditions.
- iv. Copies of the relevant liability insurance policies are received.
- v. That the cost of all advertising is met by the event organisers.
- vi. Emergency Services are contacted regarding the holding of this event with details of the dates, locations and time frames.
- vii. As per the Traffic Management Plan provisions all emergency services will be accommodated and access provided through the sites as required.
- viii. The applicant/s are responsible under the Health and Safety at Work Act 2015 for all health and safety risks associated with this activity and must take reasonably practicable steps to ensure the safety of all persons during these temporary road closures.
- ix. The applicant/s have in place at all times, appropriate Health and Safety measures (to prevent harm to any persons), including (but not limited to) any measures provided for in the submitted Health and Safety Plans including any conditions attached.

3.0 Background – Te Horopaki

- 3.1 This report covers the application to hold events, being:
 - Blossom Weekend. Karamu Road from Eastbourne St East to Heretaunga St & Heretaunga St from Karamu Rd to Warren St. The road closure will be between 8.00am to 8.00pm, Sunday,

25th September 2022. The purpose of this road closure is to hold the Blossom Weekend Festival.

- **The Spring Show**. Prospect Road Between Royston and King Street from 6.00am until 7.00pm Saturday, 15th October 2022. The purpose of this road closure is to hold Spring Carnival Race Day.
- 3.2 The above temporary road closures will be managed in accordance with the New Zealand Transport Agency Code of Practice Temporary Traffic Management (CoPTTM).
- 3.3 Traffic Management Plans (TMP) are to be submitted to the Hastings District Council and the TMPs will be approved for implementation, subject to the temporary road closure applications being approved.
- 3.4 A temporary road closure checklist, set out under the consultation section of the report, details the necessary items that the organisers need to submit as part of their applications for the above proposed temporary road closures.
- 3.5 GIS maps showing the extent of the proposed temporary road closures are attached (Attachments 1, 2, 3 and 4).
- 3.6 At the time of writing this report there were no planned road works that will affect or impact the above temporary road closures.

4.0 Discussion – *Te Matapakitanga*

4.1 The above events are being undertaken by:

The Hasting District Council – this will be the **second** closure of this section of **Heretaunga Street & Karamu Road** during the 2022 calendar year and this will be the **first** temporary closure of this section of **Prospect Road**. The average daily traffic count for Heretaunga St is 4724 and for Prospect Road is 645 vehicles per day.

The above roads have been chosen specifically for their suitability for holding the respective events or services.

5.0 Options – *Ngā Kōwhiringa*

Option One - Recommended Option - Te Kowhiringa Tuatahi – Te Kowhiringa Tutohunga

5.1 Option A is the preferred option. It recommends the Committee approve the temporary road closures detailed above, subject to conditions that will ensure public safety is maintained.

Temporary road closure options listed below:

- **Option A:** Approve some or all of the temporary road closures detailed above.
- Advantages: These events can proceed and contribute to the safe use of roads within the district for these proposed events.
- Disadvantages: Traffic will be impeded for a short period of time on specific roads.

- Disadvantages: The proposed events may need to be cancelled.

1.0 Executive Summary – *Te Kaupapa Me Te Whakarāpopototanga*

1.1 The purpose of this report is to obtain a decision from the Civic and Administration Subcommittee in regard to the following temporary road closures as requested below. This request arises from the need to inform and gain Hastings District Council ("the Council") approval in order to comply with the legal process to temporarily close the roads listed below:

Elwood Road: from Karamu Rd to Otene Rd. The road closure will be between 7.00am to 6.00pm, Friday, 21st October 2022. The purpose of this road closure is to hold the HB A & P Show, Peoples' Day.

Te Aute Rd: #4 to Roundabout, **Havelock Rd** - #8 to Roundabout, **Joll Rd** – 10b to Roundabout, **Napier Rd** – Treachers Lane to roundabout, **Te Mata Rd** – Duart Rd to Roundabout. The road closure will be between 9.00am to 4.30pm, Saturday, 29th October 2022. The purpose of this road closure is to hold a Street Festival.

- 1.2 Given that there are no submissions in opposition to the closures and subject to the recommended conditions the activities can proceed and be undertaken in a safe and controlled environment. The risks associated with these closures can then be minimised and safely managed to Council's satisfaction.
- 1.3 As part of the notification process for these proposed temporary road closures, representatives visited each of the persons deemed to be affected by the proposed closures. This is an important part of each proposed temporary road closure and is undertaken by the respective applicant involved. - ii. The Traffic Management Plans including provision for appropriate signage is approved by the Traffic Management Coordinator acting under delegated authority.
- iii. The Traffic Management Plans must be complied with including any specific conditions.

- v. That the cost of all advertising is met by the event organisers.
- vi. Emergency Services are contacted regarding the holding of this event with details of the dates, locations and time frames.

1.0 Executive Summary – *Te Kaupapa Me Te Whakarāpopototanga*

- 1.1 The purpose of this report is to obtain a decision from the Civic and Administration Subcommittee regarding the allocation of grants from the Vibrancy Fund.
- 1.2 The Vibrancy Fund is open to groups or individuals to apply for vibrancy events or activations in the city centre, such as festivals, music, murals and temporary installations.
- 1.3 Past recipients of this funding include: Bumper Boats (Hastings City Business Association), Music in the City Centre (Wyn Drabble) and Fun in the Mud (Kjelsty Hanson). These events have provided a positive impact to the community in the city centre.
- 1.4 This report relates to the allocation of funding for the 2022/23 financial year.
- 1.5 This report concludes by recommending that the funds be allocated to those applicants assessed by the Subcommittee as having the highest merit, being of wide appeal, being accessible and deliver to the needs of the community.

2.0 Recommendations - Ngā Tūtohunga A) That the Civic and Administration Subcommittee receive the report titled Vibrancy Fund Applications dated 6 September 2022.

B) That the Civic and Administration Subcommittee review the applications to the Vibrancy Fund.

C) That the Civic and Administration Subcommittee consider the applications for the Vibrancy Fund against the criteria and allocate funds to those applicants whom it considers will best assist Council to achieve its desired community outcomes, from the total funding available of **\$25,000.00**.

3.0 Background – Te Horopaki

- 3.1 \$50,000 is available each financial year for the delivery of vibrancy activations or events in the city centre by members of the community.
- 3.2 This funding is split into two rounds of \$25,000: Round 1 for delivery within the six months 1 July to 31 December 2022). Applications for Round 2 will open on 1 July 2022, for delivery for the six months 1 January to 30 June 2023).
- 3.3 The current applications for this funding round total \$55,207.93 (as set out in the table in **Attachment 1**).
- 3.4 To be eligible for funding, groups or individuals need to show how their project fits with one or more of the priorities below (summarised from the application form):
 - 1. Aligns with the Hastings District Council Toi-Tu framework.
 - 2. Supports the local creative community.
 - 3. Promotes happy, healthy and active communities.

4.0 Discussion – Te Matapakitanga

- 4.1 As requested at an earlier Subcommittee meeting, on 4 May 2021, officers have actively made the public more aware of the Vibrancy Fund criteria including advertising via social media and the Hastings Mail.
- 4.2 Nine applications have been received for this Round 2 funding round (details of each are included in **Attachment 2).**

5.0 Options – Ngā Kōwhiringa

Project Rationale	Vesica Aotearoa has been executing public art activations since 2018. With over 50 public installations since inception we are an agency dedicated to creating temporary and interesting spatial interruptions in urban settings.
Project Activities	The project is defined by a temporary architectural pavilion. It is a shelter in the most fundamental sense of the term. It is a definition of place. It is a space that is neither inside nor out, neither enclosed nor fully open. It is a space intended to create a unique backdrop for social and cultural interaction to occur. A space owned by no-one yet belonging to everyone.
	The lightweight timber frame belies its apparent fragility through the build up of members and appropriate tension elements, to create a rigid and structural frame.
	Draped shade cloth, used predominantly for agricultural purposes becomes the envelope of the space, suspended from, and between the wooden frame. A semi-transparent, permeable material, it allows one to view inside and out simultaneously, whilst also creating a perceived sense of enclosure. The draped nature of the fabric on the timber frame means it is subject to the wind, allowing it to billow gently as it responds to the changing environment around it.

	The whole pavilion becomes an amplifier for the surrounding environment; wind, sun and rain are embraced, as opposed to mitigated. This amplification of the natural world allows one to experience a deeper connection to nature and its ever-changing expressions. Drawings its cues from the agricultural infrastructure so prevalent in the Hawkes Bay area, the pavilion becomes an expression of place through its use of materiality, form and environmental response. The timber used is the same profile as fencing battens, the shade cloth is synonymous with the Heretaunga plains and its myriad of orchards and crop farms; the steel cable, a utilitarian material in its own right lends an industrial yet familiar aesthetic. All these elements combined form the basis of an architecture that is born directly out of a response to its context. Not only have these materials been employed for their utility and relation to context but also for their economic viability. Relatively cost effective, and also readily available, the materiality is key to understanding this project as a reflection of time and place. The use of found materials and applying them in unexpected ways can lead to unexpected affordances and experiences. It forces the viewer to contemplate on the use of materials and how these are used in the construction of our public spaces. - The level of financial assistance and also demonstrates efforts to seek other funding.
- That the funding applied for is not going towards "business-as-usual" or ongoing operational expenses.
- Support for / the utilisation of local talent, product and with a sustainable approach wherever possible.
- Flexibility of timing of a project wherever possible Vibrancy funded projects will be
 programmed throughout the financial year (July 1 June 30), as it is important the
 projects are scheduled/delivered over the 12 months to ensure continuity of
 vibrancy within the CBD throughout the year. Therefore consideration of the timing,
 duration, locality and programming of a project within the yearly calendar is
 extremely important.
