Subject: Rural Halls Maintenance Fund 2022-2023

1.0 Executive Summary – *Te Kaupapa Me Te Whakarāpopototanga*

- 1.1 The purpose of this report is to obtain a decision from the Rural Halls Subcommittee on the allocation of the remaining funds to applicants to the Rural Halls Fund 2022.
- 1.2 The Rural Halls Subcommittee distributed \$35,661 to 3 groups at the June 2022 meeting, leaving 10 applications undecided and \$26,239 remaining to distribute.
- 1.3 The Subcommittee at the June 2022 meeting requested officers to come back with a recommendation to distribute the remaining funds.
- 1.4 This report contributes to the purpose of local government by primarily promoting social wellbeing and more specifically through the Council's strategic objective by ensuring that the District heritage is conserved for future generations.
- 1.5 This report concludes by recommending that specific grant allocations are made to eligible applicants to the Rural Halls Maintenance Fund 2022.

2.0 Recommendations - Ngā Tūtohunga

- A) That the Rural Halls Subcommittee receive the report titled Rural Halls Maintenance Fund 2022-2023 dated 5 September 2022.
- B) That the following grants be allocated from the 2022/2023 Rural Halls Fund:

3.0 Background – Te Horopaki

- 3.1 Rural halls are important to the communities around them because they provide a venue for social and cultural events, and are a focal point or meeting place for the rural community. Council is responsible for 21 halls in the plains and rural district of Hastings, which must be for the benefit of the rural community.
- 3.2 The Rural Halls Fund has an annual allocation of \$50,000 (excluding GST) to be distributed as grants to rural halls of Hastings District. This is an annual funding round which normally opens in April each year, for allocation in the subsequent financial year.
- 3.3 The annual Rural Halls Fund budget is split in two sections:
 - \$20,000 for Council contribution to maintenance projects per year
 - \$30,000 for Council contribution to earthquake assessments and subsequent strengthening work per year
- 3.4 The Rural Halls Fund Policy 2017 outlines the administration of the fund.
- 3.5 The Rural Hall Subcommittee made an amendment to the Rural Halls Fund Policy in 2020, removing the need for the hall to have 50% funding. Halls have still been asked to outline how they are contributing to the overall costs, and this can be seen in their applications.
- 3.6 The Rural Halls Subcommittee will still favour applications that show the halls have made or attempted to make a financial contribution to the Hall.

4.0 Discussion – *Te Matapakitanga*

- 4.1 The 2022 Rural Halls Maintenance Fund opened on the 1st April and closed on the 30th April.
- 4.2 13 applications were received.
- 4.3 3 applications were approved in June 2022 (subsequently approved by Council on 4 August 2022).

- 4.4 The remaining 10 applications are attached to the report (Attachment 1).
- 4.5 As per the Rural Halls Subcommittee recommendation the remaining 10 halls have all been visited and photographs of the projects have been taken. An Officer comment and recommendation is also with each application.
- 4.6 A officer from the Building Assets team has also reviewed the applications.
- 4.7 The Rural Community Board has adopted the following priorities of work for building maintenance, to use as a guideline in assessing applications to the Rural Halls Maintenance Fund:

Priority 1:

Work required for the maintenance or restoration of Health and Safety elements of the building. This includes work to the structure to maintain or improve strength to required standards, work to remove hazards such as unprotected falls, and work to soil drainage and effluent disposal systems. Other examples include:

- Improvement or treatment of contaminated water supply
- Replacement of dangerous wiring
- Work on unsanitary plumbing
- Work to provide compliance with safety from falling
- Maintenance of food preparation surfaces in kitchens

Priority 2:

Completion of detailed earthquake assessments, and subsequent strengthening work.

Priority 3:

Work required to maintain weather tightness and protect external fabric from deterioration, for example:

- Replacement of roofing and external cladding or other work to render the building weatherproof
- Exterior repainting or repairs to exterior cladding especially timber cladding and joinery
- Repiling
- Replacement of rainwater disposal systems

Priority 4:

Work required to ablution areas and kitchens to maintain imperviousness of floor and walls to service areas. (Please note: Work to food preparation surfaces would be included in Priority 1)

- Replacement of vinyl flooring to service areas
- Painting of internal walls, ceilings to service areas
- Replacement of fittings and flooring

Priority 5:

Work to maintain appearance in other spaces

- General flooring replacement
- General repainting and redecoration

- 4.9 The two reserve funds build from carry-forwards of unused funds each funding round and can be used to fund projects which may have been delayed from previous funding rounds, or priority projects where the funding requested exceeds the annual available budget in any year.
- 4.10 \$70,000 from the earthquake assessment and strengthening budget reserve has been committed to the Detailed Seismic Assessments (DSA) of the following 6 halls:

Kaiwaka Hall	Pakowhai Hall	Tūtira Hall
Kererū Hall	Sherenden Hall	Matapiro Hall

4.11 This earthquake assessment project is the outcome of the Rural Halls Subcommittee resolution from the meeting on Monday, 9 September 2019, which was subsequently approved by Council at its meeting on 26 September 2019:

C)	That the current Rural Halls Fund earthquake assessment and strengthening budget (\$30,000) and the Rural Halls Fund reserve earthquake assessment and strengthening budget (\$30,000) be used to complete Earthquake Assessments on the halls recommended and prioritised by the Parks and Property Services Team, as per their report dated Monday 9 September 2019 (19/746).
	With the reasons for this decision being that the objective of the decision will contribute to meeting the current and future needs of communities for good quality local infrastructure, i.e. Rural Halls.

CARRIED

- 4.12 The final tender for the DSA came back at \$70,000 which is \$10,000 above the original \$60,000 estimate. This extra \$10,000 has also come from the Rural Halls Fund Reserve Earthquake assessment and strengthening.
- 4.13 The contract for the DSA is expected to start on or about Thursday, 1 September 2022 and it is anticipated completion will be on or before Wednesday, 1 March 2023.
- 4.14 If any buildings fall short of minimum %NBS (National Building Standard) recommendations of options for their remediation will be included in the final report. However, the DSAs will not include detailed engineering designs or cost estimates for strengthening work.
- 4.15 13 applications were received totalling **\$292,193.24** to the 2022 Rural Halls Maintenance Fund with a maintenance focus; three have already been approved.
- 4.16 As per the Rural Halls Subcommittee recommendation the remaining 10 halls have all been visited and photographs of the projects taken. An Officer comment and recommendation is also with each application as requested by the Subcommittee.

5.0 Options – Ngā Kōwhiringa

5.1 Option One - Recommended Option - Te Kōwhiringa Tuatahi – Te Kōwhiringa Tūtohunga

- 5.1.1 Option One is for the committee to agree with the officer recommendations and fund the additional 5 applications, this is the preferred option because these projects will progress the maintenance that is required to enable continued use of these halls.
- 5.1.2 This option would be funded using the whole of the maintenance budget with the remaining amount coming from the earthquake assessment and strengthening reserve.

5.2 Option Two – Status Quo - Te Kōwhiringa Tuarua – Te Āhuatanga o nāianei

Option Two is to not fund any applications to the 2022/23 Rural Halls Fund.

5.3 **Option Three – Te Köwhiringa Tuaturu**

Option Three is to fund some or another combination of the applications to the 2022/23 Rural Halls Fund. Each application is an individual application, any combination of applications can be accepted.

6.0 Next steps – Te Anga Whakamua

- 6.1 If approved a funding agreement will be drawn up between each of the groups and Council outlining the roles and responsibilities of each party.
- 6.2 Upon receiving the signed funding agreement and invoice from the group, payment will be made in line with the Council's finance policy.
- 6.3 At the end of the project the group is required to submit an accountability report to ensure the funds were spent correctly as per their funding agreement.
