The Council has done a fantastic job over the last five years of investing in Hastings. It's a much nicer city to be in, with so much more to see and do. This must be bringing more people in, and boosting spending in the inner city; it's such a shame to slow down on this awesome progress now. This is more than a "nice to have", it's a smart investment in our future.

Good work on the 3 waters plan. It's a shame councils are stuck with this, but this plan sounds good.

Agree with the growth strategy too. We should be looking into medium- and high-density housing in existing urban areas regardless, instead of creeping further into highly productive land. We don't want to be Selwyn.

Disagree that central govt should be responsible for social housing - Hastings has done a good job at looking after our people. Times are tough, and this support for people who are doing it tough is important. Especially with a central government that is more focused on tax breaks for the wealthy than helping people who are struggling financially. It's great if Council can step in and continue to help here.

Is there more we can do in the waste and recycling space? Collecting food waste sounds great, but there must also be further recycling opportunities, or circular economy initiatives. Perhaps the private sector can help out a bit here, with innovative new ways to reduce our waste? We can't keep expanding the landfill forever.

This is grim reading where essentially, we are paying a lot more in rates and cannot expect any enhancements in our community for 10 years. This just repairs and maintains.

The biggest spend is infrastructure repair and maintenance, so this is the area of most potential savings. Council needs to assure ratepayers that there is a minimisation of compliance costs and 'red tape', and that works are done efficiently and quickly. I have discussed this with an Auckland based roading engineer who visits Hawke's Bay regularly, and her observation is that works here seem to take a long time and are not done efficiently. There should be cost savings there.

The second biggest cost is paying out cyclone damaged properties. This is a massive cost for ratepayers, and it would be easier to accept if we had a breakdown of costs and knew what proportion of this cost is covered by central government and insurance companies. It is also necessary for us to know what the plan is for when more properties are 'written off' in future weather events (and we can count on having another within the timeframe of this plan). How liable are rate payers for uninsured, under-insured and uninsurable properties? Will rates go up more every time we have weather events?

#### Share your thoughts here . . .

Council's current plan proposals are in response to unprecedented natural events. Unfortunately this comes very soon after Council has taken on more debt for land/property purchases in Hastings and Havelock North and for water and wastewater upgrades. My concern is that in response to the unforeseen demands made by Cyclone Gabrielle, Council and Council staff have not looked more carefully for cost savings elsewhere and making better use of existing expenditure and contracted outcomes.

For example

Council's salary and wages bill appears high, and is planned to increase in future years. This needs to be carefully scrutinised.

In the context of Cyclone recovery, have Council looked carefully at managing recovery project embellishments? For example the proposed replacement to the damaged one lane Puketapu Bridge is a new three lane structure. Whilst a nice to have is this necessary? How many other recovery projects are being embellished with "nice to haves".

Are Council's Contractors being held to account for completing basic maintenance for which they are already being paid under Lump Sum and Monthly Charges. For example, in roading, both urban and rural, I believe evidence shows maintenance of road stormwater assets is well below standard. This is then cruely exposed when extreme weather events occur. Basic sealed pavement maintenance is below standard and has been for some time. Contractors wait until the pavement is broken before intervening, whereas timely interventions such as targeted wheel track sealing can be used to slow deterioration and improve levels of service. Our communities should feel the best use is being made of rates and subsidies, and that money is being spent wisely. The highly emotional and necessary "cyclone response" is likely masking poor maintenance contract performance and outcomes. Whilst often hard to accept, Council and its suppliers must ensure we get value for money in all areas.

Council proposes a 25% rate increase next year, and reductions in increases in subsequent years. My concern is that a future Council can just as quickly reverse this approach and choose to increase rates more, on top of 25% next year. As with any large organisation, if unforeseen events occur, you must first look to make savings in overheads and "nice to haves". I do not feel enough tension has been applied in these areas to reduce the real current and future pain for ratepayers.

Can you please give this feedback your consideration.

In our current environment the council needs to focus on deliverables, especially around roading, stormwater, and the bridge projects. Council needs to regularly inform the rate payer on their projects progress along with a breakdown of cost relating to these projects to ensure that the public is aware of any budget blowouts and why this has happened. You owe it to us as rate payers now that we are to carry the burden of past council negligence and wasteful spending on non-essential infrastructure and maintenance. Maintenance is a set of processes and practices which aim to ensure the continuous and efficient operation of machinery, equipment, and other types of assets and infrastructure. Cyclone Gabrielle has certainly delivered on the council's short comings highlighting so many areas that need immediate attention. Council has to become openly accountable to the rate payer and deliver clear and accurate costs and be accountable on all these major projects. Gone are the days of just throwing more rate payers money at a project that was not priced correctly or initially designed and thought through properly.

As I was involved in the aftermath of the cyclone it was clear to me that we need better communication and processes with local councils, share resources to keep costs down and implement a standard disaster recovery plan that not only meets each area's needs but can function as one that includes outside resources. Power is another big issue, and this will always play out as being an unknown quantity. As an example, the pump stations stopped and there was no back up generation, Clive suffered because of this. This is an area that really needs serious attention as unnecessary surface flooding caused so much damage, resulting in huge hikes in personal insurance costs. As a rate payer we are being hit from every direction with increased costs. Councils need to look harder at joint financing opportunities, joint bulk procurement opportunities and have clear processes when it comes to implementation. Council needs to show a significant performance increase in reducing internal operational drag and improved time management to give us any confidence.

Overall, I think council is on the right track with the long-term plan, however for the next 3 years council needs to be focused on reducing their civic commitments to help reduce our rate increase. Concentrate on major infrastructure that improves the region's ability to cope with another weather event, improved roading for better transportation around the area, with new storm water management around our main roads and rivers, build better bridges. Stop supporting unnecessary or underutilized services immediately, reduce all community programs as we can survive without them for a period of time.

Dear Councilors,

Below are my considered thoughts in relation to the Long Term Plan (LTP) Consultation Document (proposal) that is posted in the Hastings District Council website.

Firstly, I acknowledge the depth of thought and rationalization that has gone into the preparation of the said LTP, and compliment those who were involved in its formation.

Secondly, as a regional community we need to draw a line in the sand in 2024 and stop looking at supposed facts through distorted rose-tinted glasses. This practice is doing us no good whatsoever. The time has come for New Zealanders as a whole to start looking at the facts "in the raw" (see things for what they actually are) and then dealing with them head-on.

And now I turn my attention to the LTP itself...

- 1. The rates increases proposed deny/ ignore the existence of a downtrodden regional and national economy particularly the technical economic recession that N.Z. is experiencing currently and the stagflation status that is looking increasingly likely to happen. The proposed rates increases also fail to recognize that Hawke's Bay (overall) is very much still in the throes of trying to get to its feet again after two significant events: a) 6 years of incompetent central government which had zero economic enablement focus/ orientation and capability, and b) the adverse effects of Cyclone Gabrielle (both physical and psychological).
- 2. Because the Hastings District Council is placing such considerable reliance (51 %) of its budget revenue funding on rates, it is imposing financial vulnerability on those ratepayers who have relatively moderate-low income means to afford the proposed rates increases. Has the HDC not considered selling or leasing at least some of its fixed assets in order to reduce this reliance on ratepayers?
- 3. While I understand the stated justification to proceed to perform most particularly bridge and road infrastructural repair/ replacement work sooner rather than later, often in life the "ideal" is simply not achievable particularly where affordability is concerned. This is very much the case where HDC's ambition to perform as many bridge/ road repairs and/ or replacements as possible within the stated timeframe is concerned. That is, it is simply not affordable to do so, especially when such a heavy reliance is placed upon ratepayer funding.

4. If the HDC is not prepared to – and/ or cannot – source alternative funding to direct/ contribute specifically towards the rebuilding of priority Hawke's Bay infrastructural assets, then the ONLY practical realistic way to drive the recovery of Hawke's Bay is by incrementally repairing/ replacing infrastructure and raising the performance and achievements of the Hawke's Bay economy, concurrently. These two primary focuses need to occur hand-in-hand (simultaneously) so that a recovering Hawke's Bay economy generates improved economic outcomes (including increased household incomes), that then progressively enable infrastructure to be repaired/ replaced through increases in rates contributions. And as infrastructure is repaired/ replaced this will in turn help drive economic recovery and improvement. Each fuels the other – a true symbiotic relationship.

My strongest recommendation is that the HDC reviews its road and bridge repair/ replacement projects, identifying the highest priority repair/ replacement work needed, down to the least pressing work needed - spreading this work over the next 10 years (not 3 years). So the 50 % overall increase in rates identified in the LTP may become instead 55-60% (considering inflationary adjustments and added cost of HDC borrowing during the next 10 years), yet the 55-60% overall rates increase is spread over 10 years, averaging therefore a 5.5-6% annual rates increase.

By taking a longer timeframe to repair/ rebuild/ replace infrastructure, two very important comparative benefits would eventuate:

- a) The level of annual rates increase would be more affordable for more property owners. Therefore, the HDC would be more likely to see a greater number of property owners actually pay their total HDC rates invoice, which would result in the HDC receiving an overall higher rates volume (\$) annually – to direct to its planned activities as per the LTP. I am quite certain that if the rates increases were to be persevered with as per the proposed LTP then the HDC would see a relatively high number of property owners default on paying their rates invoices either in part or wholly.
- b) Infrastructure repairs/ replacements happening progressively/ incrementally would start to stimulate/ aid the recovery of the Hawke's Bay economy, which would then progressively increase the affordability of subsequent rates increases at the 5.5 – 6.0 % rate of increase per annum until Year 10.

Note - this comment on Page 39 in the LTP is both perplexing and naïve:

"Open up more areas for growth development.

Due to the increased financial risk in a slowing economy, this option is not recommended."

The ONLY way to prudently and reliably rebuild any economy (be it either a regional or national economy) is through stimulating and increasing productivity; which in turn generates more income, which consequently has a flow-on positive money supply effect that reignites demand (through increased spending and savings/ investment capacity).

The HDC needs to look more <u>broadly</u> at recovery options/ measures – <u>beyond</u> infrastructure repair/ replacement. Help drive the recovery of the Hawke's Bay region through better enabling/ empowering Hawke's Bay businesses – existing and new alike, which in turn will help fund HDC LTP budgeted expenditure. I have a document that I prepared for a Napier City Councilor (at his request) some years ago, which is focused on exactly how councils can practically assist in stimulating and growing an economy. Please feel free to ask for this document if you have an interest to do so.

To this end, the Regional Business Partner Programme needs to be closely reviewed as a matter of priority. Determine "why" it isn't delivering favourable outcomes for the Hawke's Bay region that everyone wants it to. I was instrumental in enhancing this programme back in 2015, by advising John Key (then Prime Minister) that it needed to incorporate a deliberate "consulting" dimension. The aforementioned review should determine "what" commercial advice is being given and to what effect (i.e. what outcomes have been achieved consequently).

5. I feel compelled to make a heartfelt point here. I have been living with my nucleus family at 539 Apley Road, Puketapu for the past 15 years. In all of this time the only tangible benefit that we have received from HDC activity has been the clearing of Puketitiri Road and Dartmoor Road following Cyclone Gabrielle, the occasional filling-in of potholes that appear in these roads, and access to the Springfield Transfer Station. That's it.

We are the self-appointed guardians of a beautiful property – which we have made so through our own toil/ labour, which includes the preservation of around 2 acres of Native Bush. We intend to continue to preserve this bush throughout our remaining tenure on this property (we will not be clearing it for productive/ monetary generating purposes) – a direct benefit for Hawke's Bay and greater New Zealand from an economic perspective.

We have purposely chosen this rural lifestyle, so as to avoid reliance on as much public infrastructure as possible, so we don't expect to pay ever-increasing rates (HDC and HBRC alike). If I continue to see attempts to raise the rates associated with our property, which I deem to be unjustifiable, I may well instigate legal proceedings to challenge such attempts in Court.

6. The HDC needs to listen closely to Hawke's Bay ratepayers at this time, and take heed of what the majority of formal submissions point to. We live in a democratic country, and an inherent aspect of democracy is to act according to the wishes of the majority. The Hawke's Bay Regional Council are currently facing public outrage due to its refusal to act according to the wishes of 90 % of submitters on the topic of changing the basis of HBRC rates calculations. This is poor governance and reflects an autocratic council

organization. I strongly advise that the HDC does not follow this example set by the HBRC.

### Conclusion -

I'd like to see the LTP revised; to better reflect the current fragile state of the (overall) Hawke's Bay economy, the current underperforming (and high cost of living) state of the New Zealand economy as a whole, and the likelihood that New Zealand may well soon enter a state of stagflation. This is about facing-up to the <u>realistic</u> nature of where New Zealand is <u>actually</u> at currently.

I'd like to see this revision also include:

- a) Reprioritizing which infrastructure is targeted for repair/ replacement and when.
   State the priority sequence in the LTP name the given bridge/ road and its priority rating/ timeframe for repair/ replacement.
- b) Consideration given to sourcing HDC budget revenue from <u>alternative</u> sources (e.g. private individuals I can share the name of one individual who may be interested and who has the financial wherewithal to help, if the HDC has an appetite to explore this option).
- c) The expressed exclusion of rural and lifestyle property owners from being contributors to HDC asset development which does not benefit them (e.g. fresh water supply, waste water treatment, etc).
- d) The HDC give deep consideration to further reducing non-priority HDC servicing costs (public services).
- e) HDC enactments/ undertakings in accordance with what the wishes of the majority of public submissions reflect.
- f) After Year 10, rates to be adjusted <u>downwards</u>, to reflect the fact that all planned infrastructural repairs/ replacements would have been completed by then. Ratepayers need to know at the front-end of entering this period of significant and consistent rates increases that ultimately this regime is for a <u>finite</u> (fixed) time period, after which rates will be reduced in line with a reduced reliance on rates to fund HDC activities (planned expenditure).

#### To Whom It May Concern,

I am VERY concerned about the way in which councils in the Hawke's Bay region are driving their own agenda into place with or without reference to public consultation input. The most recent case of this being the HBRC's decision to drive its change in the way it calculates HBRC rates – for these rates to be based on the Capital value of properties; despite the fact that 90 % of formal submissions made opposed/rejected this endeavour.

This is sheer arrogance, and is dismissive of democratic rights and reflects very poor governance.

Where the HDC is concerned, I strongly suggest that you do not follow the same arrogant pathway to achieving what you desire, For I foresee litigation being inevitable in the event that you do.

Here's where I'm at with the HDC's proposed rates increases...

- The HDC like any other council (and any business for that matter) needs to cut its
  cloth to suit the jacket size that is realistic obtainable/ achievable at the time, despite
  its desires/ preferences to achieve whatever planned projects within its preferred/
  desired timeframes.
- 2. The HDC needs to be realistic in its understanding of where the wider New Zealand economy is at currently we are virtually the worst performing country out of all OECD countries where productivity is concerned. So the HDC needs to ask itself the all important question of "can rate payers realistically generally be expected to afford rates increases given the low productivity (and associated income) levels generally being achieved? And the answer that realistic mindsets will arrive at is a resounding "no".
- 3. If the HDC was to practice "good governance", it would review its projects and associated timeframes in order to:
  - a. Rationalise the shrinking/ culling/ phasing/ deferral of particular projects and act accordingly.
  - b. Rationalise the re-prioritising of particular projects and act accordingly.
  - c. Rationalise the assigned timeframes within particular projects are expected to be implemented and act accordingly.
- 4. All government councils around New Zealand need to stop resorting to what is essentially "taxing" ratepayers more and more in order to achieve their funding requirements. Ratepayer affordability of this measure/ ploy is becoming less and less, and will soon result in ratepayers defaulting on paying their rates or only paying a level of rates which they can afford at the time. This is a <u>regressive</u> approach to digging New Zealand out of the deep financial mess that we're in presently.

- 5. Instead of hiking rates, the HDC needs to derive <u>alternative</u> ways of achieving its budget funding requirements. Necessarily, these alternative ways must/ should focus on <u>PRODUCTIVITY improvement enablement</u>. All councils need to decide whether they are truly an integrated part of New Zealand society or not right now it very much seems that they don't have this sense. On this point, the HDC and HBRC might like to contact David Seymour for a copy of the paper that the 'Game Changer Collective' wrote a few years ago which David has a copy of. Or you can request it directly from me. I was the main author of this paper. Within you will find a range of REALISTIC ideas for stimulating our economy, that don't rely on invoicing Kiwis for successively higher levels of rates.
- 6. I laughed (cynically and knowingly) at the way in which the HBRC ignored my formal submission with respect to factoring-in an allowance for the fact that approximately 50 % of our property is planted in native bush. I suggested that if the HBRC was to either change the basis of its rates calculations or increase rates then it should/ must include an offset factor reflecting such plantings (which don't serve any productive/ income purpose and positively contribute to a healthy climate/ environment). This dismissive attitude spoke volumes, reaffirming my belief that all that councils are really trying to do is increase their rates (tax) pools to meet their own desired projects. Shameful.

Lastly, <u>nowhere</u> in New Zealand can sustain successively higher levels of rates. Particularly when the ROI in relation to rates is indiscernible. For example, the greatest benefit that me and my family nucleus have received during my lifetime in Hawke's Bay is the clearing of the Puketitiri Road and Dartmoor Valley Road of landslides and silt deposits following Cyclone Gabrielle. That's it. Other than that we occasionally see a pothole filled-in with tar seal, only to reappear a short time afterwards due to the quality of the tar seal fill used.

So is the HDC actually <u>enablement</u> orientated, or is it instead self-interested – like so many other human organisations around the world?

I look forward to your reply.

### Background

Mayfair community planning in 2017 identified two key aspirations - upgrade of Bill Mathewson Park and the establishment of a community hub. Upgrades to the park subsequently happened, but the setting up of the community hub remains outstanding.

Initial scoping of potential sites was conducted in late 2022, with St Martins Hall at 1120 Willowpark Rd North being the preferred site due to its proximity and existing facilities - see Attachment A.

The Mayfair Community Group has recently undertaken engagement on a proposed community hub to understand whether this continued to be an aspiration in the community. The engagement took place from 10 - 15 April 2024.

The engagement utilised a mixed methods approach, including online and face-to-face. The online survey was promoted through social media and emails. A hard copy survey was conducted face-to-face at the Community Day on 13 April at Mayfair School. Copies were also made available at Barnardos, the Kindergarten and St Martins.

There was a total of 171 engagements over the period, with the responses overwhelming indicating support for a hub and identifying the range of services and activities that should be delivered through the hub - see Attachment B.

The Mayfair Community Group met in late April 2024 to review the input and agree priorities for the proposed community hub. The group also agreed that the initial establishment of the community hub would draw on a range of existing resources and infrastructure in the community, which may not be completely fit for purpose, but which would allow a 12-month pilot of the hub. At the completion of the initial 12 months, a longer-term plan for the community hub will be considered through a review.

#### Establishing a Mayfair Community Hub

The overall drive for the establishment of a community hub in Mayfair is to develop strong and positive community members. particularly youth, children, parents and the elderly. It is hoped that creating positive community members will reduce anti-social behaviours, including those associated the local gang presence and the use of drugs.

Based on the engagement input, it is proposed that the community hub focus on coordinating the delivery of the following activities and services:

- 1 Health and Wellbeing
- a. Medical services and health clinics including immunisations, health checks and health promotion
- b. Mental health services including counselling and resources, responding to the needs of youth and the elderly
- c. Nutrition support which considers the needs of the elderly and children.
- 2. Strengthening Families
- a. Parenting classes
- b. Family violence support c. Ministry of Social Development services
- d. Kainga Ora services and housing support.
- 3. Community Safety
- a. Neighbourhood Support
- b. Police presence
- c. Overseeing delivery of broader safety measures including community security cameras and traffic calming.
- 4. Advocacy, Education and Employment
- a. Access to advocacy services including Citizens Advice Bureau, Community Law, Justice of the Peace
- Budgeting services
- c. Access to adult education including development of a relationship with EIT.
- 5. Community Connection
- a. Overseeing activities that build community connection including a BBQ in the park, a fenced playground in the park, community
- b. Support community leadership development particularly youth mentorship.

The community hub would also broker and promote activities and services being delivered by others within or near the community including; fitness activities, cooking lessons, pataka kai, coffee groups, dental services, clothing support and the like.

### Collaborative Approach

A range of partners and stakeholders will be critical to establishing the community hub including; Hastings District Council, The Anglican Parish of Greater Hastings, Ministry of Social Development, Kainga Ora, NZ Police, local health providers, local social service providers, community organisations, funding organisations and others.

Managers and Coordinators of other local community hubs and centres will be sought as mentors and advisors for the establishment of the Mayfair hub.

A communications and stakeholder engagement plan will be developed to carefully manage and balance the implementation of the hub activities and services with existing services being delivered at St Martins and also to ensure neighbours to the property are well-informed

Review of Hub Implementation

A review will be conducted towards the end of the initial 12 months of operation to consider utilisation of the facility, activities and services. This may lead to the commissioning of a feasibility study to determine ongoing viability of activities and services, suitability of site and sustainable funding sources.



### Share your thoughts here . . .

The proposed rate increases are obscene and reflect a council which lacks prudent financial controls and shows complete disrespect for ratepayers in what are extremely difficult financial times. The whole country is feeling the pain due to the expending excesses of both the previous Labour Governments, lack of control by the Reserve Bank Governor and this is not helped by wasteful spending by councils on `feel good' projects which are not essential core Council requirements and undertakings - the Hastings District Council is not immune from these criticisms.

I urge you to take my following advice on board and go back to providing services that are core to District and other Councils - namely clean water, waste water, storm water, rubbish collecting and maintaining roads and footpaths. All non essential spending outside these areas should be put on hold and probably dropped altogether.

Here are some ideas which I strongly recommend you adopt:

- No more cycleways
- 2. Stop round a bouts like the one recently installed at the Frederick Street/Caroline Road intersection. This roundabout has destroyed traffic flow and has made the intersection much more dangerous. As someone who uses both Frederick Street and Caroline Road regularly, sometimes daily, the new roundabout makes me very nervous as I approach it mainly because of the speed of other traffic, the failure of drivers on Frederick Street in particular to give way and the fact that almost no drivers using the round a bout indicate. It is an accident waiting to happen on a daily basis and a waste of taxpayers money trying to fix a problem that did not exist
- 3. Remove the Maori Wards before the next Local Body elections. It is clear legislation is going to be passed making referenda a requirement for the installation of Maori Wards. There is no doubt that Council will lose such a referendum comprehensively and therefore you should be pre-emptive in removing the Wards to save the cost of said referendum and separate elections. We are one people and Councils should recognise that instead of being racially divisive and pandering to Maori activism.
- 4. My understanding is Hastings District Council is one of the most advanced in respect of the requirements for Local Waters Done Well. If you have not done so I suggest that you should immediately contact Minister Simeon Brown so this may be further advanced and so ratepayers receive the rate reduction benefits as evidenced by the plan recently announced for Auckland. There seems no reason to me why these benefits should not flow through New Zealand and also no reason that with the work already completed that Hastings District Council should not be at the forefront for receiving these benefits.
- 5. I am sure my view that support received from the previous Labour Government was grossly inadequate when compared to the damage done throughout the district by Cyclone Gabrielle is generally accepted. Are you keeping the pressure on the new Coalition Government for more financial help with this. In Catherine Wedd and Katie Nimon Hawkes Bay has two up and coming MP's, future Cabinet Members I would think and the Hastings District Council area runs through both of their Electorates as I understand it. If you are not, Council should be taking full advantage of their capabilities and commitment to Hawkes Bay. I do not think we have been so well served since the days of Craig Foss and Chris Tremain. Government must be persuaded to carry more of the cost of the restoration of all of Hawkes Bay following this disaster.
- 6. Get back to communicating in English only. It is the common language of your District and would have resulted in probably four fewer pages in the recently sent out which would have been a small saving for ratepayers. Most Maori I know, friends, contacts and work colleagues of many years standing do not want to be involved in the pandering and patronisation of Maori as has been the case in the last 6 years in particular. Have a look and see how many Maori are by choice are on the General Roll throughout New Zealand I think it is a big majority over the activists infesting the Maori Roll.
- 7. Do not pander to the Climate Change alarmists. Sure the climate is changing just as it has since time began. Blaming Cyclone Gabrielle on Climate Change is misleading it was more likely an after effect of the Tongan Volcano eruption.

In conclusion there was a saying in common use when I was growing up in Hawkes Bay in the 1950's and 1960's - save the pennies and the pounds will look after themselves. It is past time that the Hastings District Council followed that ethic - because when it is all said and done Councillors and Staff are employees of Ratepayers, not the other way round.

Think again about your levels of proposed borrowing - it is going to be a noose around ratepayers neckes for several generations to come.

We bought in Hastings in 2021. First time homebuyers.

Our rates were \$2800 when we bought. They are now anticipated to be \$4500. In three years, thats a 60% increase. When coupled with the cost of living crisis, HDC is significantly contributing to making home ownership in Hastings unaffordable. If this rates increase is adopted and the upward trend looks to stay, we will not be able to stay in Hastings long term.

I believe rates should be higher for investment properties, and lower for first home buyers/single property owners.

Addressing natural hazard preparations and recovery, I do not want to see home owners who have chosen lower-risk home locations shoulder the cost for those who have chosen to live by waterways and in other higher risk zones. I believe encouraging people to relocate away from high risk areas should be incentivised via lower rates.



In the light of that we/you need to focuss funding on sorting our waterways out, humans have spent the last 800 or so years mucking up the environment - early polynesian/ Maori burnt down half our forests to grow kumera, bracken fern and to provide habitat for Moa. Settlers in the last 180 years have completley changed the way that waterways run so that almost all creeks, streams and rivers are in artificial channels designed to speed the flow of water thus making peak flows larger and erosion much much greater to say nothing of the loss of soil from slopes denuded of their forest cover. with 89% approx of our forest cover gone and about the same amount of flood mitigating swamps gone the Cyclone damage was totally forseeable. We have also centralised our services so they are reliant on " just in time" delivery via large road destroying trucks.

Growth is a oszi scheme and sooner or later we will have to pay for it. Lets focuss on sustainability and a good lifestyle for all Hawkes Bay citizens. More people means more infrastructure, etc, etc which has to be paid for out of the same area of land, so more intensification, more erosion, more housing etc until the whole thing falls over. Yes GDP looks good, like after the Christchurch earthquake but most people end up with less each and the whole standard of living drops for most people. We are dropping battery hens to put in infill housing so creating battery people!

Debt plan must be to find more savings - stop paying ever increasing amounts to Council and Council staff and counsultants. Make sports and cycle ways pay their way. We now have professional sports woth million/billions and we still subsidise them. Cycles should be registered and chipped and pay a fee for they use of cycleways. Buses are a waste of money. For the few people who cannot drive/afford a car we can set up a volunteer survice or the can work or cycle ?? Isn't that why we have spent megabucks on cycle and walkways.

Suggesting rates increases of 25% does not reflect the reality of the economic crisis that New Zealanders are experiencing with increases across the board to food, power charges, insurance, fuel, maintenance, health services and many other staples of life, quite unmatched by increases in income. As a general rule, I believe that rates should not increase beyond the rate of inflation however accept that the impact of Cyclone Gabriel will have an extraordinary effect requiring an increase above that of inflation. Take a leaf out of the current NZ Government handbook and set a rates target in the order of 12% and instruct the management to bring back options on how this can be achieved.

HDC get real with your budgeting and do what others have to, cut your cloth to suit the ability of your constituents to pay.

#### Share your thoughts here . . .

I believe that a large number of ratepayers will struggle to meet the potential 158% increase in rates over the next three years, and in representing ratepayers, councillors must cut increases therefore to the bare minimum required to meet basic services and necessary cyclone recovery costs.

"Normal" operating costs and the rate increases required to cover those should be increased at a percentage not greater than annual inflation, and given the premium required to pay cyclone recovery costs, basic rate increases should be kept well below inflation in the medium term. During the cyclone recovery period, "nice to have" projects should be deferred, and wasteful vanity projects such as the recently completed water compound beside the Council Buildings cancelled completely. Hopefully in hindsight councillors are finally embarrassed by the monies they have wasted on that facility, its location, and surrounds.

Rather than blending cyclone recovery costs into the overall rate take, I feel strongly that rates should be presented annually as a basic operating rate to meet normal Council Operating Costs, with Cyclone Recovery Costs identified as an annual levy in addition to that. Council is then required to manage operating budgets and keep increases within inflation levels, and once the cyclone recovery costs are met, the overall rates take will not been inflated unrealistically.

HDC has been severely effected by woody biomass brought down the catchment and will continue to be so. This woody debris has significant value when converted to certified biochar. The same system which produces the certified biochar + carbon removal credits, can also achieve similar outcomes from green slash, waste treatment plant biosolids and other feedstocks. This proposal is currently in various stages of acceptance with three other District Councils, and is deployed in more than 70 projects globally. The case for the system is commercially astute, providing a direct economic lift of approximately \$150/Tonne of woody debris, plus earnings. The secondary benefits include energy generation providing resilience and reduced cost. Our suggestion is that such a system would remove the operational expense of woody biomass disposal, provide significant new revenues to the local economy and/or Council, and provide local energy generation for industry or homes.


Making biochar has been an ancient, low-tech practice.

The biochar produced, when added to soil, made plants grow better and require less fertilizer and watering. The traditional methods were limited in modern terms, posing problems with environmental impacts, particularly emissions, the qualities of the biochar itself and in their limited potential and scalability.



The large woody biomass problem is here now and for years to come.

Is modern Biochar capable of being a large part of the solution?



### Can these biochar facilities deal with the 900,000+ Tonnes of LWD we currently have?

The units are modular, operating alone or in parallel, each processing 12000 T/a. 15 units would process the current inventory within 5 years. Spread across the East Coast, perhaps: Wairoa; Matawhero; Te Karaka; Tolaga Bay; Tokomaru Bay; Ruatoria; Te Araroa.

In each case, local relationships with community, forest owners, contractors, transport are essential to outcomes being sustained: "locally led, regionally supported, and centrally enabled", Phase Two of the Government response to the MILU.

This substantially fulfils the MILU Response Phase One requirements 6.1 and 6.3:

6.1 effective, sufficient clean-up of woody debris to manage the risks it presents:


6.2 strengthening resource management functions and decisionmaking:

6.3 strengthening partnerships for future resilience; and

6.4 reducing risks of new woody debris flows and sedimentation.

We consider the Rodney Green Arenas to be regional assets, providing well-being and recreation to all of Hawke's Bay. We work to provide a quality venue for indoor sports, which have outstripped grass-based sports participation in recent years. We are grateful for the support we get from Hastings and Napier councils, but sadly, we are at a crossroads in terms of financial sustainability due to increased power and insurance costs beyond our control.

Our power costs have doubled, and insurance costs are now unaffordable, having risen from \$70k in 2020 to a hefty \$390k for the 2025 financial year. We're asking for support from both councils to help us navigate this massive increase in premiums, whether by additional OPEX support or some other means of "sharing the load" to ensure we can continue offering a quality indoor sports and events centre to Hawke's Bay. This level of insurance premium is financially unsustainable for our Trust.

We are asking for a meeting to discuss options, our facility is a real asset to our community and especially to the youth of Hawke's

Subject: Operational and Renewal support for The Regional Indoor Sports and Events Centre Trust from Hastings District Council.

The submission to the Hastings District Council's long-term plan highlights the need for increased operational and renewal support for the Rodney Green Arenas, a premier sports facility. The council has supported the arena for over a decade with \$55,000 p/a plus GST for operational expenses (OPEX) and \$35,000 p/a plus GST for capital expenses (CAPEX) renewals each year. However, these figures have not been adjusted for inflation, leading to a loss in buying power.

Despite an increase in OPEX to \$85,000 p/a plus GST after the completion of the new Rodney Green Foundation Arena, the funds are insufficient to cover rising costs due to inflation. The primary objectives of the arena include providing public sports and recreational facilities for physical development, fun, and well-being in the region, as well as offering educational resources for EIT students in various disciplines. Encouragement of sport plays a major role in the wellbeing of our community, helping our youth to reach their full potential through positive pathways and enabling our elderly to live independently and healthy for longer.

The Trust's objectives focus on optimising facility utilisation, aligning revenue activity with expenses, accommodating large events for the region, attracting visitors to the region to support economic wellbeing, aligning strategies with HDC and meeting the growing demand for high-quality indoor recreational facilities. The Trust is committed to innovation, efficiency, cost reduction, superior customer service, and health and safety standards.

In recent years, the Regional Indoor Sports and Events Centre Trust has experienced significant growth, thanks to investments from Hastings District Council's \$2M donation and central government and charitable organisations like Lottery Grants. We completed a \$19.5 million expansion, adding 6 new indoor courts to meet increasing demand and host national and international sports events, demonstrating our dedication to serving the community. This submission calls for increased financial support to ensure the facility's continued success and service to the community.

Considering the critical role that the Regional Indoor Sports and Events Centre plays in fostering the well-being and development of our community, we respectfully request the following decisions from the Hastings District Council:

- 1. Operational Support: We kindly ask for the operational support provided by the Hastings District Council to be increased to \$300,000 OPEX per annum, plus GST, to help cover the growing operational expenses of Rodney Green Arenas. One primary concern is the massive spike in our insurance premiums. From a manageable \$70,000 in 2020, it shot up to \$390,000 by 2024. This sharp increase is putting immense strain on our financial sustainability, and the future of Rodney Green Arenas hangs in the balance.
- 2. Renewal Support: Additionally, we seek an increase in the renewal support from the Hastings District Council to \$150,000 CAPEX per annum, plus GST, to ensure that essential capital improvements and maintenance are adequately funded.
- **3. Annual Inflation Adjustment:** Most importantly, we request that these new proposed operational and renewal support figures be inflation-adjusted annually. This measure is crucial to future-proof

this invaluable community asset, guaranteeing that the quality of the experience our community members have when they participate in the arena remains exceptional.

By making these adjustments, the Hastings District Council will continue to play a pivotal role in supporting our people's physical and educational development while contributing to the overall well-being of our community. We appreciate your consideration of this proposal and look forward to your support in ensuring the ongoing success and excellence of the Regional Indoor Sports and Events Centre Trust.
