Camberley Community Plan 2020-2025

1.0 Executive Summary – Te Kaupapa Me Te Whakarāpopototanga

1.1 The purpose of this report is to present the Camberley Community Plan to the Great Communities Subcommittee for recommendation for approval; following the approval the paper will be presented to the Strategy & Policy Committee for endorsement.

2.0 Recommendations – Ngā Tūtohunga

- A) That the Great Communities Subcommittee receive the report titled Camberley Community Plan 2020-2025 dated 13 April 2021.
- B) That the Subcommittee approve the Camberley Community Plan and that the plan is forwarded to the Strategy & Policy Committee for endorsement.

3.0 Background – Te Horopaki

3.1 Hastings District Council first started developing community plans with community in 2002 as a way for Council to engage with and provide additional support to communities of interest.

- 3.2 Council currently has 11 community plans, 2 under development and nearing completion and 1 new community to commence development of their plan. Each plan's goals, aspirations and actions are unique to each community.
- 3.3 This is Camberley's third Community Plan and was developed by the Camberley Community throughout 2019 and 2020.
- 3.4 The first Camberley Community Plan was developed in 2003. The plan was reviewed with further consultation over 2007-2008, and a second edition of the Plan was published in 2009. The second plan was developed in 2016 creating the 2016-2020 community plan.
- 3.5 Previous plans have seen the development of the Camberley Community Centre; upgrades to the playground in Kirkpatrick Park including a Splash Pad and BBQ station; community murals; bus shelters; programmes at the community centre and much more.
- 3.6 For this new plan JMP Consultants were contracted by HDC to consult with and engage the Camberley Community to help articulate and compile a robust and user friendly document that ultimately takes their hopes and concerns and transforms them into goals and aspirations for the community, its stakeholders and partners to help support and deliver.
- 3.7 This community plan will support the development of the Camberley Masterplan that Council has committed to developing.

4.0 Discussion – Te Matapakitanga

- 4.1 The Camberley Community Plan 2020-2025 was developed by the Camberley Community and is attached. The development of the Plan was driven by a working group comprised of both residents from the Camberley Community, Council Officers and key partners.
- 4.2 The vision the Camberley Community Plan 2020-2025 is:
 - "Together we are developing our community for a strong future"
 - "Kia Kotahi rā tātau e anga whakamua nei tō tātou hapori ki to taro o te ora"
 - "Tatou Galulue Fa'atasi e fausia ai se fa'avae malosi mo se lumanai ole lau tele o tagatanu'u Hastings"
- 4.3 The Camberley Community have identified 3 key priority areas;
 - Community Wellbeing;
 - Community Safety and;
 - Community Facilities & Infrastructure
- 4.4 Each priority area has a list of actions for implementation (see attached Camberley Community Plan 2020-2025).
- 4.5 During COVID-19 the Camberley Community Plan working group met via Zoom to reprioritise the Community Plan.
- 4.6 This saw the Community Wellbeing priority being given a higher priority with the goal of a Wellbeing Hub to be developed and implemented as the main priority. This was to ensure that our Camberley residents were able to come through the recovery phase of COVID 19.

5.0 Options – *Ngā Kōwhiringa*

6.1 If the Subcommittee approves the Camberley Community Plan 2020-2025 the Plan will then be presented by the Camberley Community to the Strategy & Policy Committee for endorsement and then implementation of the actions within the plan will commence.

Summary of Considerations - He Whakarāpopoto Whakaarohanga

That purpose is to enable democratic local decision-making and action by (and on behalf of) communities, and to promote the social, economic, environmental, and cultural wellbeing of communities in the present and for the future.

The community plan development process has entailed a range of engagement with the Camberley community, a largely Māori populated community, and so engagement with Māori has been in an urban context and based setting, as opposed to specific hapū and or marae engagement. Nonetheless, it is envisaged that the greater Master and Spatial Plan for the Camberley Community that while much larger in scope than the community plan, will be a more in-depth process that will engage both urban Māori residents and hapū / iwi too including Te Taiwhenua o Heretaunga, Ngāti Kahungunu Iwi Inc, Heretaunga Tamatea Settlement Trust, as well as marae whom local 'Kahungunu' residents do affiliate to.

Sustainability - Te Toitūtanga

Financial considerations - Ngā Whakaarohanga Ahumoni

Subcommittee approval of the Camberley Community Plan 2020-2025 would signal support at a high level for the collaborative approach being taken to the delivery of actions.

Council actions within this plan will be funded through existing budgets.

Community members will be supported by Council Officers to approach funders, partners and stakeholders for actions that sit outside of Council.

Introduction

The development of the Camberley community plan commenced in late 2019 and prior to finalisation in the first half of 2020 was reviewed by the community in light of the recent COVID-19 event. Key actions were updated to respond to community needs identified during that event.

JMP consultants were contracted by the Hastings District Council to consult with and engage the Camberley Community to help articulate and compile a robust and user (reader) friendly document that ultimately takes their hopes and concerns and transforms them into goals and aspirations for the community, its stakeholders and partners to help support and deliver. The outcome of over 12 months of meetings, consultation, planning and investigating is the Camberley Community Plan 2020 – 2025.





OVERVIEW OF CAMBERLEY

Camberley is located in the Heretaunga tribal boundary of Ngati Kahungunu. Descended from the Takitimu waka, Kahungunu and his many legends remain a rich part of the Hawke's Bay and its history.

On the sunny eastern coast of the North Island, the Heretaunga plains has rich fertile land that has become home to many agricultural productions such as numerous vineyards, orchards and small farms.

Located in the heart of Heretaunga, Camberley is a suburb of the Hastings District which is an inclusive diverse multicultural community with a population of 1881. On average, Camberley has a more youthful population than other suburbs of Hastings with a median age of 29, compared to 39 for the city of Hastings. Just over half of the population identify as Maori.

Within Camberley, there are many growth opportunities in the suburb. Camberley is a key location that will benefit greatly from employment services and investment into the community that provide meaningful employment opportunities.

The Camberley Community Centre is a hub of activity for the community. Often used as a contact point for those that want to get involved in community activities, plans and developments. The Centre also offers a range of programmes such as fitness classes for kaumatua, a basketball academy, kid's Breakfast Club and Homework Club during the school terms as well as school holiday programs.

Post Covid-19, the community would like to see more whanau and hauora activities and programs so the centre is seen and eventually becomes a wellbeing hub or place.





WHANAU ORA AT CAMBERLEY SCHOOL

Over the past two years, the leadership at Camberley School has continued to increase its focus on embedding wellbeing in the curriculum, including by developing educators, to create a place and space which supports tamariki, rangatahi and their whanau to thrive.

The focus on wellbeing is being taken forward from a Te Ao Maori perspective, by implementing Rongo Mauri (healing and well being Hub) and strengthening the communities' link to culture. It is an approach that is responsive to the needs of the Camberley community, as determined by the local whanau and community.

Through a Whanau Ora-type initiative which has been funded by Ministry of Social Development for the first part of 2020, the school has brought in a local specialist who has extensive mirimiri, healing and social work experience, to engage with young people and their whanau to build plans and take steps forward together. Working out of the school and also the homes of whanau, the goal is to tap into all the key parts of the young person's life to foster healthy relationships and behaviours, so both the individual and the whanau succeed in their dreams and aspirations, improving overall wellbeing. There are five key whanau workers that work in Rongo Mauri.

To further foster the likelihood of success, whanau wellbeing planning is underpinned by broader community development being delivered by the school and other partners through wananga and services.

The overall approach recognises the importance of not giving young people and their whanau solutions – rather it is about supporting them to find the solutions that work for their unique whanau and broader community environment and support whanau to achieve their aspirations.

Already having a significant impact on the lives of local young people and their whanau, the focus for 2021 will be on developing and embedding the initiative through sustainable funding to continue to increase the reach into early childhood education, intermediate and secondary schools local to the Camberley community.

Partnerships

Alongside the community a group of key partners including government agencies and service providers were engaged to consider the community priorities as outlined in the Action Plan which they could support to be delivered.

These partners included: Police, MSD, Camberley School, HBDHB, TTOH, MOE, TPK, NKII, Heretaunga Intermediate, Camberley Kindergarten, Kainga Ora, Camberley Planning Committee, Plunket, Women's Refuge, Sport HB, Elections NZ, Community Law Centre, Age Concern, Budget First.

Hastings District Council have committed to developing a Camberley Master Plan working closely with the Camberley community and key partners. Master Plans are strategic documents that strategically align to the Council Long Term Plan (LTP): The Master Plan overarches Commity Plans and other place based plans and incorporates potential road design, housing development and zoning as well as economic and social trends for the next 20 – 30 years. Master Plans and the development of, involves a number of agencies including government departments, local business, schools and community. Community Plans by design are to support the communities' aspirations.



Action Plan

Camberley has had three previous community plans, which have helped improve the amenities and some social aspects in the community. These previous community plans are responsible for the opening of the Community Centre, Breakfast Club, bus shelters, new playground, and upgrades to Kirkpatrick Park such as the splash pad and BBQ station and programmes held at the Community Centre.

The key actions in this community plan come directly from the community members of Camberley. Along with its partners, the Hastings District Council conducted more than 150 engagements with community members, online and face to face, between September 2019 and May 2020. This ranged from online surveys to in person engagement through street BBQs, community meetings and activities with the elderly and rangatahi.

Through this range of discussion, there were three key areas of focus identified in priority order:

Community Wellbeing

Community Safety

Community Facilities & Infrastructure

Within each of these areas of focus there are a set of actions that form the basis of the community plan for 2020-2023.

Partners have been identified for each action. Some of the actions will benefit more from community coordination rather than resourcing, such as whanau-based activities which are identified in the Community Wellbeing section.
