council and society still isn't ready to respect whānau then get out of our way because we're moving forward with or without pakeha regardless of these last bastions of colonial imperial and undemocratic oppression. So hang on to your monocultural monopoly over whānau wellbeing and flourishing for as long as you can, because its fading. The wellbeing of whānau is our fundamental birthright and I would be ashamed of myself if I was part of a regime that petitioned these stupid questions and processes, and dishonoured the tamariki and mokopuna of Heretaunga and more broadly, Aotearoa. Having a voice will ensure the interests of our Maori community will be acknowledged and listened to.

The people of the land of whom have a positive notion and invested interest in positive future developments...should definitely have a seat and voice within the council. Change is needed to make changes.

Makes sense to include Maori, after all we are supposed to be partners of Te Tiriti o Waitangi. It is time (180 odd years later) to trust us is it not? Māori wards would mean a legitimate voice for Māori, manaakitanga, whakawhanaungatanga, and kaitiakitanga might actually manifest, resulting in meeting the three guiding principles as set out in The Treaty of Waitangi...

The current model of council is seen more of a dictatorship, which is serving only a portion of society. When we are not part of the decision making but are told we must pay and do as you ask, then we are no more than children and are inconsequential. The council must have Maori representation going forward for credibility! Or we will truly be the same old colonised and oppressed land for a new century.

He iwi kotahi tatou (not the Don Brash version) was a biblical-based encouragement to inspire both parties to the Treaty of Waitangi in a relationship for the benefit of both parties. We cannot say let's do this together in a tokenistic way any more, we have 180+ years of mistrust to make up for. We can do this. Let's truly work together and listen deeper to what our Treaty partners wants. Why would they not want the best for all our future generations?

I wanna keep this short but there is so much evidence and data that highlights the need for Māori wards. As a council that should be demonstrating a Tiriti led partnership, it should almost be undoubtedly a majority vote for the establishment of Māori wards. You can find as many excuses as you can, but when you address the underlying issue that's not only highlighted thru numbers and stats but thru real stories from real people from the community. There IS an expectation for you to vote in favour. If you fail to do so, I can almost guarantee an uproar of disappointment amongst your Māori community.

Be a true leader and lead by example by voting in favour of establishing Māori wards.

No I do not support the formation of Maori wards in Hastings. This is race based politics and will only cause further racial conflict and tensions between Maori and non Maori.

Councillors should be elected by the general public (not a segment of the population) based on their individual skill sets and the benefits they add to the local community, not by their ethnicity.

It is time to move forward as one (New Zealanders) with the same rules applying to all, politics based on race is a backward step.

I think as a district we need to work together not have more and more segregation for individual groups. Work together as one for a common goal of making our district a great place to live. Lena Ormsbys article on page 2 of Hawkes Bay today makes it crystal clear why wards based on race are a bad idea "Should I tick Maori or NZ European ... " one box or the other means denying part of a persons heritage.

To put it more simply we are all human and of mixed race. We all have access to Councilinformation and can contact individualCouncil members if we are not happy.

To further complicate things those who are voted in by Maori to represent Maori will need to declare their interest and refrain from voting on any issue relating to Maori.

We also need to address the issue of seat capture by radical Iwi who are not representative of Maori in general.

Finally Council is about making sure we have the water, roads, rubbish collection ie services that allow a modern society to function. Keepin mind that virtually all Maori voted with their feet to move to modern western settlements. They did not stay in their tribal villages under chiefly rule with its poor sanitation, privileged status for a ruling few.

For what it's worth: you are rushing this, there's been hardly any consultation. It is 100% separatism and apartheid. We are 1 nation with 1 people! Let the best people for the job get voted to do the job. Not a group of maories that will also have a veto. It's totally wrong and does not do any favours to other minority groups.

Councillors are supposed to represent their constituents values, wants and needs and I think the needs of Maori are already represented in this way. Also, every major project already requires consultation with relevant Maori groups where their cultural interests are possibly impacted. Where Council supposedly gets it wrong they are soon bought to account, e.g. the Te Mata Peak walking track debacle. So, I believe there is already plenty of representation for Maori and, to establish Maori Wards as well would create a disparity with other ethnic communities that have no representation in Hastings other than their elected Councillor.

The presentation of this consultation process in Maori first, then in English tells me that we are already putting emphasis on all things Maori, and I don't believe additional emphasis will help promote racial harmony in the long term or provide any additional benefit to the region. This is doubling Maori representation opportunities

History is currently being distorted as a pre-condition for a tribal grab by part-Maoris (tribal elites) for wealth and power.

Te Tiriti gave equality to all the people of New Zealand.

Special rights/privileges for one race are a violation of the democratic principle that we should all be treated equally.

We are all New Zealanders equal before the law and with equal representation in government.

The Maori voice should be heard in exactly the same way as the European voice, or the Asian voice, or the Pacifika voice, or any other voice here in New Zealand. Today, New Zealand should be a country where every citizen is valued, irrespective of when they or their ancestors arrived in this country. Rights should be based on citizenship not ethnicity.

I urge you not to succumb to this recent pestilence of separatism and race privilege for a favoured few (tribal elites). You as a council need to say "No" to this undemocratic establishment of Maori wards (race based appointees). This process undermines accountable democracy.

When I vote for council representatives I have always considered what is best for the whole community. I would expect any elected councillor to be aware of issues of particular interest to Maori and other sectors and to seek appropriate advice where necessary.

The establishment of Maori wards implies a representation for a particular sector only.

representation of the community and ratepayers is democratically adequate when it is done on the basisi of a representation of those very community candidates.

We are ONE people - New Zealanders.

In a democracy all people are elected to office on their ability. There should not be separatism with Maori wards. We are all equal and all nationalities should be eligible to vote on the general role to ensure our community as a whole is well served.

I'm concerned about the increasing segregation in New Zealand.

If we are going to lose a rural councilor by having Maori wards I would be against establishing Maori wards. When they established the HDC in 1998 we had 4 Rural councilors.

A few years ago the HDC amalgamated the four wards into two. Now if this goes ahead we could lose another Rural councilor so will have only one to represent the vast rural area.

The Hastings District Council IS NOT the Hastings City Council. The rural ratepayers that live in this vast area need to be represented around the table by more then one Councilor.

If Maori wish to represent their Council, then they should be elected like everyone else.

We have ticked the NO box for supporting the establishment of Maori Wards but that is ONLY for the 2022 Elections. For the moment we would like to retain the status quo and have the matter considered in Council's 2024/25 review ahead of the 2025 Elections. This will give us more time to understand how the Maori Wards would function. Clearer explanations of how the governance would work everyone. Thank you

I do not support the establishment of Maori wards in Hastings District as it will be a retrograde step in terms of race relations. There are already Maori City Councillors who have been voted in to represent Maori as well as tauiwi. I am a 4th generation NZ Chinese. My great-grandfather came to NZ in 1896 and my wife's great-grandfather came out in 1888. In fact the first Chinese came to NZ in 1842 and since then have been discriminated against by Govt policies which resulted in the apology to NZ Chinese by PM Helen Clark in February 2002.

There have be a number of Chinese Mayors and City Councilors in NZ over the years elected by the general public on their merits, to progress their cities for all of their citizens. Some that come to mind are George Gee -Petone, Peter Chin -Dunedin, Meng Foon-Gisborne, Deputy Mayors - William Wong - Carterton, Molly Ngan Kee -Lower Hutt and no doubt many city councillors that I am not aware of.

If Maori wards are ever established would it be considered appropriate to establish Chinese wards or Indian wards in the future in cities where there is a high ethnic population. This not something that I support as it encourages separatism not the multi-cultural society that NZ is and should be. Further there are few full Maori in NZ and in the future all our descendants will be essentially be a mixture of European fruit salad or Asian stir fry. What happens then ??

I write to oppose the establishment of Maori wards for the Hastings District Council.

If the aim is to reduce the deficit in social outcomes for Maori I support its intention. However the proposal is likely to be counter-productive. I set out a number of reasons which lead to this conclusion.

- 1- Anti-Democratic -The proposal establishes a right for members of a specific cultural group to choose their own representatives. Whilst the democratic principle of one vote one person is maintained, this would lead to special rights for some ratepayers based on culture. This is fundamentally undemocratic. In an attempt to redress one set of imbalances the proposal would establish a new set of inequities and weaken communities at a time when social cohesion is under extreme pressure.
- 2- Ineffective The proposal, at best, will be ineffective. At worst it will be destructive. Maori are well represented by capable councillors, partnership group members and iwi reps among others. There is little assurance the proposed model would improve representation or social outcomes. The Maori Parliamentary seats are a comparable model. In terms of improving social and environmental disparities, their effects remain dubious and contentious. The 1986 Royal Commission on the Electoral System found the model had not helped Maori and recommended it be abolished. Many of the most prominent maori parliamentarians have been elected through general seats.
- 3- Partnership is Weakened Regardless of its intentions, the proposal erodes rather than promotes racial harmony, perpetuates division and weakens partnership. Creating special conditions for one cultural group by definition sub-ordinates others, stimulates resentment and drives people apart. Its ineffectiveness is also likely to lead to disappointment.
- 4-Dangerous Constitutional Change The proposal deviates from the existing even-handed

approach to representation. A regime based on cultural orientation is radically different from a ward system based on residential location. In the future there may well be multiple arguments put forward to allow other groups (defined by cultural or other parameters) to guarantee their representation at council. A precedent set now could expedite the erosion of democratic protections for rate-payers in general. The evangelic zeal with which the proposal has been promoted may well have overlooked this long term implication.

5-Evidence of Community Support is Lacking - This issue has generated considerable debate nationally and doubts about the wisdom of the proposal are widespread. The period for consultation is alarmingly brief. It is still questionable whether the majority of ratepayers support the proposal and whether councillors are acting as representatives of the whole community. A prudent council, would objectively examine the long term outcomes of the proposal at a pace appropriate for such a consequential change. Giving particularly consideration to its constitutional implications as society evolves and demographic patterns alter would be wise.

I reiterate my support for initiatives that will, strengthen communities and improve social outcomes for Maori. In my view this proposal will have the opposite effect and should not be adopted.

Reading the biographies of candidates who stood for Hastings DC at the last election many of them including some I voted for identified themselves as having Maori heritage and they got elected . If this proposal is enacted the council will almost certainly be dominated by people of Maori heritage while they constitute only around 20% of the total population . In the midst of all of the current hype largely driven by the current government we tend to overlook the fact that Maori are invaders of this country who have now been joined by members of many ethnic communities . Will we next extend the same ward system to other ethnic minorities ?

Why did you leave it up to the Maori committee to decide whether or not there would be Maori seats? Establishing Māori wards on Hastings District Council

Maungaharuru-Tangitû Trust

This letter is written on behalf of the Maungaharuru-Tangitū Trust (MTT). MTT is the post-settlement governance entity representing the hapū – Marangatūhetaua (Ngāti Tū), Ngāti Whakaari, Ngāti Tauira, Ngāti Kurumōkihi (formerly known as Ngāti Tatara), Ngāti Te Ruruku ki Tangoio and Ngāti Tahu (Hapū). Our takiwā (traditional area) encompasses the Waitaha River in the north to Keteketerau in the south (the outlet of the earlier Te Whanganui-ā-Orotu also known as the Napier Inner Harbour which was in existence before the 1931 Napier earthquake), and from the Maungaharuru Range in the west to the coast and beyond to Tangitū (the sea) in the east. Our marae is Tangoio Marae.

Support for the establishment of Māori Wards by 2022

MTT supports the establishment by Hastings District Council (HDC) of Māori wards for voters on the Māori roll to elect councillors onto HDC with effect from the 2022 elections. Te Tiriti o Waitangi sets out an expectation of partnership at all levels of government, including local government, which cannot be met without sufficient representation.

Rather than empowering HDC with the ability to establish Māori wards, sections 4, 14(1)(d) and 81 of the Local Government Act 2002 arguably **require** HDC to establish Māori wards, as to do otherwise would not be to "provide opportunities for Māori to contribute to its decision-making processes" consistently with Te Tiriti o Waitangi.

Currently, tangata whenua are under-represented in local government and prevented from effective representation by virtue of a system which does not sufficiently reflect tangata whenua interests. Quoting Margaret Mutu, "it is at the local authority level where Māori resources are most immediately affected, where decisions are made that directly affect their ancestral lands, waterways, seas, and within them, the wāhi tapu" and where tangata whenua interests are most vulnerable. This gives rise to the necessity for tangata whenua organisations to involve themselves in litigation against planning decisions which could be mitigated by better representation in decision making.

It is likely that the establishment of Māori wards will also reduce costs for HDC. Better, upfront Māori participation in the decision making phase should enhance the consultation required during planning and minimise litigation following planning decisions which adversely affect Māori.

The government has taken a step to remove barriers to Māori representation. Voting to establish Māori wards will take a further step toward providing for more effective representation of Māori and a stronger Māori perspective in the decision making of local government. It is imperative that HDC address this issue urgently, and in time for the 2022 elections so that Māori participation is not further delayed.

While we are in support of the establishment by HDC of Māori wards in principle, we do not consider the proposals go far enough and also provide some additional comments below on specific aspects of the proposal.

Tangata Whenua

The current options do not acknowledge the tangata whenua of this district. At a local level, those iwi and hapû who hold mana whenua in the area are the representative bodies whose rangatiratanga was required to be protected under Te Tiriti o Waitangi. The rôpû with rangatiratanga are the only groups able to make decisions impacting their whenua and taonga. They are also best placed to make such decisions given they hold location specific matauranga. It is only representatives from these rôpû who can properly represent the views and aspirations of mana whenua. Accordingly:

- Eligibility for both voting in and standing for election in the new Māori wards should be limited to those people who are mana whenua.
- Boundaries for specific wards should be drawn and councillors elected from within those boundaries by the mana whenua within those boundaries. The electoral roll should therefore be split into the General electoral roll and a number of Māori electoral rolls, one for each particular ward.

Proportionate Representation and Number of Councillors

We acknowledge that the Local Election Act 2001 (LEA) eliminates any discretion as to the number of Māori wards which may be established by the HDC. However, in our view the formula set out for proportional representation in the LEA is not consistent with the principle of partnership under Te Tiriti o Waitangi. Instead, we consider that principle requires Māori and non-Māori be elected in equal numbers rather than merely in proportion to the number of voters registered on the Māori and general electorates.

HDC should ensure that the proportion of Māori councillors is as high as possible within the limits of the LEA to better reflect that true partnership would require equivalent representation of Māori and non-Māori on the HDC. On that basis it is preferable to ensure there remain only 9 councillors rather than increasing the number of councillors to 11 so as to avoid diluting the influence of Māori further.

In conclusion we make the following recommendations:

- 1. That HDC vote to establish Māori wards with effect from the 2022 elections.
- 2. That the number of councillors remain at 9.
