1.0 Executive Summary – *Te Kaupapa Me Te Whakarāpopototanga*

1.1 The purpose of this report is to obtain a decision from the Civic and Administration Subcommittee in regard to the following temporary road closures as requested below. This request arises from the need to inform and gain Hastings District Council (“the Council”) approval in order to comply with the legal process to temporarily close the roads listed below:

- 1.2 Given that there are no submissions in opposition to the closures and subject to the recommended conditions the activities can proceed and be undertaken in a safe and controlled environment. The risks associated with these closures can then be minimised and safely managed to Council's satisfaction.
- 1.3 As part of the notification process for these proposed temporary road closures, representatives visited each of the persons deemed to be affected by the proposed closures. This is an important part of each proposed temporary road closure and is undertaken by the respective applicant involved.

2.0 Recommendations - *Ngā Tūtohunga*

- ii. The Traffic Management Plans including provision for appropriate signage is approved by the Traffic Management Coordinator acting under delegated authority.
- iii. The Traffic Management Plans must be complied with including any specific conditions.
- iv. Copies of the relevant liability insurance policies are received.
- v. That the cost of all advertising is met by the event organisers.
- vi. Emergency Services are contacted regarding the holding of this event with details of the dates, locations and time frames.
- vii. As per the Traffic Management Plan provisions - all emergency services will be accommodated and access provided through the sites as required.
- viii. The applicant/s are responsible under the Health and Safety at Work Act 2015 for all health and safety risks associated with this activity and must take reasonably practicable steps to ensure the safety of all persons during these temporary road closures.
- ix. The applicant/s have in place at all times, appropriate Health and Safety measures (to prevent harm to any persons), including (but not limited to) any measures provided for in the submitted Health and Safety Plans including any conditions attached.

3.0 Background – *Te Horopaki*

3.1 This report covers the application by Hawke's Bay Car Club, Clubs Hastings, Ironman NZ, and Club Targa Incorporated to hold three separate sporting events, and one commemorative event being:

- i) The Hawke's Bay Car Club (HBCC): **Mangaroa Road** between Maraekakaho Road and Ru Collin Road from 9:00am until 5:00pm Sunday, 10 April 2022. The purpose of this road closure is to hold a motorsport event.
- ii) Hastings Clubs: **ANZAC Day Commemorative Services**

- 3.2 The above temporary road closures will be managed in accordance with the New Zealand Transport Agency Code of Practice Temporary Traffic Management (CoPTTM).
- 3.3 Traffic Management Plans (TMP) are to be submitted to the Hastings District Council and the TMPs will be approved for implementation, subject to the temporary road closure applications being approved.
- 3.4 The temporary road closure checklist (**Attachment 1**) details the necessary items that the organisers need to submit as part of their applications for the above proposed temporary road closures.
- 3.5 GIS maps showing the area of the temporary road closures are also attached as part of **Attachment 1**.
- 3.6 At the time of writing this report there were no planned road works that will affect or impact the above temporary road closures.

4.0 Discussion – *Te Matapakitanga*

- 4.1 The above events are being undertaken by:

- The Hawke's Bay Car Club - this will be the first temporary closure of **Mangaroa Road** during the 2022 calendar year. The Average Daily Traffic Count (AADT) is: 664 vehicles per day.
- Clubs Hastings. The ANZAC day commemorative services are held at well-known sites for a short period on this public holiday.
- Ironman NZ - this will be the first temporary closure of **Brookfields Road** during the 2022 calendar year. The Average Daily Traffic Count (AADT) is: 2207 vehicles per day.
- Club Targa Incorporated - **Taihape Road, Ōhiti Road, Matapiro Road, Crownthorpe Settlement Road, Hedgeley Road, Seafield Road, Puketitiri Road, Glengarry Road, Whakapirau Road, Raukawa Road, Te Onepū Road, Argyll Road, Middle Road and Napier Road**. This will be the first temporary closure of these roads during the 2022 calendar year except for Napier Road. The above roads have been chosen specifically for their suitability for holding a sporting event.
 - The average daily traffic counts are shown in the table below:

Napier Road is being proposed to be closed for the second time this financial with the first also being part of this report as Napier Road is also closed for part of ANZAC day commemorations. Consultation has been done by the applicants with the Havelock North Business association and affected properties. There have been no submissions regarding this requested closure.

The above roads have been chosen specifically for their suitability for holding the respective events or services.

5.0 Options – Ngā Kōwhiringa

Option One - Recommended Option - Te Kōwhiringa Tuatahi – Te Kōwhiringa Tūtohunga

- 5.1 Option A is the preferred option. It recommends the Committee approve the temporary road closures detailed above, subject to conditions that will ensure public safety is maintained.

Temporary road closure options listed below:

- **Option A:** Approve some or all of the temporary road closures detailed above.
- Advantages: These events can proceed and contribute to the safe use of roads within the district for these proposed events.
- Disadvantages: Traffic will be impeded for a short period of time on specific roads.
- **Option B:** Do not approve any of the temporary road closures detailed above.
- Advantages: Traffic will not be impeded.
- Disadvantages: The proposed events may need to be cancelled.

6.0 Next steps – Te Anga Whakamua

Summary of Considerations - He Whakarāpopoto Whakaarohanga

Fit with purpose of Local Government - E noho hāngai pū ai ki te Rangatōpū-ā-Rohe

The Council is required to give effect to the purpose of local government as set out in section 10 of the Local Government Act 2002. That purpose is to enable democratic local decision-making and action by (and on behalf of) communities, and to promote the social, economic, environmental, and cultural wellbeing of communities in the present and for the future.

“11. The council may, subject to such conditions as it thinks fit (including the imposition of a reasonable bond), and after consultation with the Police and the Ministry of Transport, close any road or part of a road to all traffic or any specified type of traffic (including pedestrian traffic).”

“(e) For a period or periods not exceeding in the aggregate 31 days in any year for any exhibition, fair, show, market, concert, film-making, race or other sporting event, or public function:

Provided that no road may be closed for any purpose specified in paragraph (e) of this clause if that closure would, in the opinion of the council, be likely to impede traffic unreasonably.”

1.0 Executive Summary – *Te Kaupapa Me Te Whakarāpopototanga*

- 1.1 The purpose of this report is to obtain a decision from the Subcommittee on the current round of allocations of grants from the Multi-year Strategic Community Partnership Fund.
- 1.2 Multi-year Strategic Community Partnership Fund is open to groups that have previously been successful obtaining a grant or funding from Council in the past and are providing a proven positive impact to the community.
- 1.3 These Multi-year contracts span two years and are reported on annually. Outcomes are reviewed each year against agreed key performance indicators, including financial ones. These contracts would commence July 2022 and cease June 2024. These two year contracts would cease in line with last year's three year contracts.
- 1.4 Applications for funding opened December 13, 2021 and closed February 28, 2022 for contracts commencing July 1 2022.
- 1.5 6 eligible applications have been received in this multiyear funding round.
- 1.6 There is a budget of \$50,000.00 for this round, however this budget can be exceeded, but additional funding will be sourced from the Single Year Grant Budget.
- 1.7 This report concludes by recommending that the funds be allocated to those applicants assessed by the Subcommittee as having the highest merit, being of wide appeal, being accessible and delivering to the needs of the community.

2.0 Recommendations - Ngā Tūtohunga

- A) That the Civic and Administration Subcommittee Meeting receive the report titled Multi-year Strategic Community Partnership Fund dated 5 April 2022.
- B) That the Committee reviews the applications to the Multi-year Strategic Community Partnership Fund ; and
- C) That the Committee approves the budget allocation to those applications whom it considers will best assist Council to achieve its desired Community Outcomes.

3.0 Background – Te Horopaki

- 3.1 During the 2019 funding review the Council implemented the ‘Contestable Funding Framework’ one of the changes in that framework was the creation of the ‘Multi-year Strategic Community Partnership Fund’.
- 3.2 In 2021 the Civic and Administration committed to 17 multi-year agreements.
- 3.3 During the 2021 Long Term Plan the budget for Community Grants was increased by \$50,000. This increase starting in year two of the LTP (2022-2023 Financial Year).
- 3.4 At the Civic and Administration Thursday, 2 December 2021 the committee resolved:
That the Committee approve the opening of a Multi-year Strategic Community Partnership Funding round in 2022.
- 3.5 To be eligible for funding, groups need to show how their project fits with one or more of the three priorities below:
 - 1. Uplifting our communities’ wellbeing by providing access to help and advice**
 - 2. Fostering a sense of pride within our district and across our diverse communities**
 - 3. Promoting happy, healthy and active communities.**

4.0 Discussion – Te Matapakitanga

- 4.1 6 eligible applications have been received in this multiyear funding round.
- 4.2 The amount requested is per annum and contracts will be for two years.
