#### 1.0 Purpose and summary - Te Kaupapa Me Te Whakarāpopototanga

- 1.1 The purpose of this report is to formalise a process for Council to determine whether or not to support remits to the 2023 Local Government New Zealand AGM.
- 1.2 One of the requirements for remits to the Local Government New Zealand AGM is that they either have the support from at least one zone or sector group meeting, or five councils.
- 1.3 It is proposed to circulate any remits seeking Council support to councillors to provide feedback to the Mayor, and the Mayor be delegated authority to determine whether or not to support the remits.

#### **2.0** Recommendations - Ngā Tūtohunga
